In February of this year, we released OS Version 3.2.1 of ADA-BAS in North America. The success of this release has been most gratifying. Remarks such as "best release ever made", "documentation much improved", "most thorough installation procedures" are very rewarding to those who have spent so many hours and so much effort in getting the new version out. There is a firm commitment from software ag that all future releases will be as reliable as the Version 3.2.1 release.

We already have started planning for and working towards the release of Version 4.1 of ADABAS. The first draft of the 4.1 reference manual and utilities manual have already been completed and sent to the technical staff for their comment. We do expect to have a great deal of revision in these two manuals before they reach a final stage. The documentation for 4.1 will be thorough and complete when the new release is made. We have plans for significant changes in the area of documentation. The design guide, which is currently a section of the Systems Programmers Guide, will be greatly expanded and become a manual unto itself. We will be looking for a great deal of input from our users (based on their experiences) for the contents of this manual. We are also developing an Operations Guide to benefit the persons responsible for operating ADABAS and making restart/recovery decisions.

I think that the last two years have seen significant changes in the documentation area and we plan that over the next two years the improvement will continue at the same pace. We do need more constructive input from the users—the one additional ingredient that would help us better meet your needs. We would appreciate your comments in writing designating the areas that need improvement and suggestions for the ways in which they could be improved.

Immediately following the release of 3.2.1 for OS, we turned our attentions to putting the DOS Version into the same shape that the OS release is in. We are planning to release DOS Version 3.2.1 in June. We are using the same standards for installation procedures, documentation, testing and thoroughness of checkout for this release.

We have a very ambitious schedule for next year, but we are organized in such a fashion that I feel we will be able to achieve the results that we have promised.

Now that the 4th International Users Conference is over, our organizational efforts must begin. Each Special Interest Group (SIG) is described briefly below. 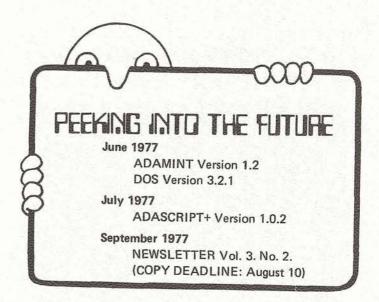

CHANGE/ENHANCEMENT REQUESTS

The enclosed revised procedure for handling requests for changes and enhancements to ADABAS is suggested for use by the ADA-BAS Users Group (ADAGROUP) in 1977/1978.

The Chairman of the Change/Enhancement Committee is elected by the Executive Committee each year at the Annual Users Conference. This year's chairman is Daniel R. Skwarcan.

Dan will review each request. It may be necessary to consolidate like requests. He will append an objective evaluation of the proposal if this is considered necessary. The chairman may contact other members of ADAGROUP, usually chairmen of Special Interest Groups, to assist in this evaluation.

If any changes are made to a request, the Chairman of the Change/Enhancement Committee will notify the original requestor before submitting the request to software ag.

All current requests will be collated and distributed to all members of ADAGROUP. Members will vote on the requests to establish a priority sequence for submitting to software ag.

Each ADABAS installation site will have 200 votes to use as it pleases. Up to 50 votes may be given to any one request. For example, one company may elect to give fifty votes to each of four requests, while another may give two votes to each of a hundred requests. Obviously the more votes given to any request, the better the chance of that request being near the top of the priority list.

The ballots must be returned to the Chairman Change/ Enhancement Committee. To be included in the count, ballots must be received within six weeks of the Users Conference. When recording your vote you may consider using the telephone or telex to eliminate the delays in the mailing system.

The Chairman Change/Enhancement Committee will then compile the complete prioritized list of requests for submitting to software ag. This will include:

- (a) All current requests sequenced as a result of the balloting.
- (b) All previous requests that software ag has agreed to implement but are not yet included in the current release of the system.

software ag will be asked to comment on all requests prior to the Users Conference. At the conference, members of ADA-GROUP will receive the complete list including software ag's responses. A meeting to discuss changes and enhancements will be scheduled.

All requests for changes/enhancements will be included in the balloting in the year they are received. From there on the action we take will depend on the response from software ag as follows:

RESPONSE

software ag announces a release Request remains on list until number for the change/ enhancement.

software ag rejects the request. i.e., the change is not planned.

software ag will consider the change/enhancement in the future.

ACTION

change implemented. It is not voted on in subsequent years.

Request is dropped from the list. Note that a deleted request may be raised again by any member of ADAGROUP.

Request remains on the list and is voted on in subsequent years.

PROCEDURE "

A request for changes and/or enhancements to ADABAS and related s o f t - w a r e a g software products may originate from any member of ADAGROUP. When requesting changes and/or enhancements, users should check the current list carefully to ensure that duplicates are not created.

Completed request forms should be sent to the Chairman of the Change/ Enhancement Committee. The Chairman for 1977/1978 is:

In order to be included in the current year's voting list, a request must be received at least 12 weeks prior to the Annual Users Conference. The procedure will function more smoothly if users submit their requests throughout the year rather than shortly before the deadline. A complete schedule for 1977/1978 will be published in the September, 1977, NEWS-LETTER.

The person submitting the request will complete the ADABAS Change/ Enhancement Request form as follows:

- 1. A short TITLE for the request, e.g., Security Violation Log.
- The CATEGORY in which the request is to be included, e.g., nucleus, MPM, ADAMINT, ADAWRITER, utilities, etc.
- 3. A complete DESCRIPTION of the change or enhancement giving sufficient detail to allow all users to fully understand the proposal. Please remember, we are interested in long term goals which we expect to see incorporated in some future release of ADABAS and not operational problems which require immediate attention.
- 4. A list of BENEFITS to the system that the requested change/ enhancement will provide.
- The date that request is submitted, name of the requestor, company name and address, and telephone number.

FOLLOWUP FROM THE USERS CONFERENCE

Some questions arose at the Change/Enhancement Requests session that we were unable to answer at that time.

- 1. Several people requested updates to the Internals Class handout as they had previously attended. Copies of the visuals used in the 3.2.1 Internals Class will be mailed during June to all past attendees. If you attended an Internals Class and do not receive a copy, please call Roy Wood in Reston. An updated Internals Manual for 3.2.1 will be distributed to the same group when the revision is completed. In the future, past attendees will only receive updated material for one year after attendance at an Internals Class. When the 4.1 Internals Class is offered, a special one-day refresher course will be offered for those who have already attended an Internals Class.
- 2. It was requested that we reconsider our response to the request for a dual logging capability. Version 4.1 will include an optional dual logging capability.
- It was requested that our response to the Change/Enhancement Requests be in the first day handout at the Conference.
 Every effort will be made to comply with this request.
- 4. It was requested that we establish a frequency and turnaround schedule for changes to the documentation and that parts of a page that are changed be noted in some manner. There is not a regular schedule for update of the documentation but typically non-cosmetic changes will be distributed within two months. All changes in a page will be noted by an asterisk in the margin.
- 5. A request was made that we provide better coordination of System Modifications, Early Warnings and Source Modifications. We understand that this does require some administration on the part of the user and we are currently soliciting suggestions for possible improvements in this area. This issue is considerably complicated by the use of many different operating systems and library maintenance software and procedures.
- Will ADASCRIPT+ make dynamic use of the Dictionary?
 It is not currently planned but ADACOM will.

In addition, there were a few additional Change/Enhancement Requests submitted to us. We will formally respond to them in the next Newsletter.

My functional responsibilities are that of project leader for our data base effort, including data base maintenance, software development and maintenance, application consultation, and DBDC training. We are completing a two year Data Dictionary development effort which will be implemented with ADABAS version 3.2.1. Our Data Dictionary will control our entire DBDC environment through interfaces with INTERCOMM sign-on/sign-off security and ADABAS security. Tentative plans for the East Central Users Group include a regional conference in September at the Associates in South Bend and another regional conference in March of 1978. Topics for discussion will be based on a poll of user preference.
