# Natural Update

The following features are to appear in the first version of Natural:

- Teleprocessing support under Com-plete and CICS for both buffered (3270-Type) and unbuffered (TTY or 2741-Type) terminals.
- 2. New "SET GLOBALS" options
  - A. Zero Printing Totally suppresses numeric fields containing all zeros.
  - B. Sound Alarm Option Assuming the terminal hardware supports an alarm (or beep) capability, Natural will sound the alarm to prompt the user for input.
  - C. Decimal Character Substitution The feature will allow for European edit mask notations.
  - Input Delimiter Character for data separation on nonbuffered terminals.
  - E. Input Assign Character for the assigning of values in keyword input mode on nonbuffered terminals.
- 3. Post-Selection Screening Limit

A search done with basic search criteria (against the inverted lists only) results in so many records being found. At this point, the user may determine that too many have been found to continue processing using extended search criteria (which reads each record). The user may, therefore, terminate the request before any physical read against the data has ever taken place.

- 4. Special Options of the "WHERE" Clause
  - A. SCAN A numeric or alphanumeric field may be scanned for a string of characters. If the argument string appears anywhere in the field to be scanned, the record is returned.
  - B. MASK The user may specify that certain characters are to appear in certain positions of the field to be masked. Any time the value of the mask matches the field to be masked, the record is returned.
  - Field Break A subcomponent of a field may be used as a break key.

## 5. NO RECORDS FOUND Condition

In an ADACOM request involving multiple FIND and/or READ statements, if a "NO RECORDS FOUND" condition exists for the innermost loop, ADACOM simply returns the "REPORT DONE" message without printing any information which may have been desired from the outermost loop. Natural, however, will allow the user to display information under this condition.

# 6. Before Break Processing

The value prior to a break condition may now be used in a title line before a report rather than being printed out after the report, which is the current case in ADACOM. Additionally, variables accumulated prior to the break may now be included in the break processing.

- 7. Enhanced Arithmetic/Assign Support
  - A. Support for binary.
  - B. "ROUNDED" option may be used for arithmetic statements.
  - C. A "MOVE" or "ASSIGN" statement which designates a range of occurrences within a numeric MU or PE field now equates to a "TOTAL FIRST, THEN MOVE" operation.
  - Parentheses are now supported in both arithmetic operations and in building search criteria.
  - E. Square root function now provided.

### 8. Update Functions


- A. DELETE To delete records from the data base.
- B. STORE To add records to the data base.
- C. UPDATE To change records which exist in the date base.

NOTE: Unlike ADASCRIPT+, Natural permits a mass delete and mass update capability.

Access to Periodic Group/Multiple Field Counts

This capability now allows the user to easily determine the highest non-null occurrence within the field or group. When used in combination with the new "GET SAME" and "FOR" statements, the count provides a logical end for a loop which may be used to determine the total number of occurrences of any one value within the field, determine the position of an occurrence within the field, etc.

- 11. "FIND" Statement Enhancements:
  - A. New System Variables Supported
    - \*ISN ISN of the record currently in process.
    - \*NUMBER Number of records found through the basic search criteria.
    - \*COUNTER Number of records which have passed both basic and extended search criteria.
- "GIVE" Option within sort now allows for retrieval of standard system functions.
- 13. "GET SAME"

This capability allows the user to read occurrence values within a periodic group or multiple value field, having previously determined the count of the highest non-null occurrence.

# 14. Histogram Statement

Similar to the ADASCRIPT+ Histogram command, the Natural version is much more powerful. The MASK and SCAN capabilities are extended to the Histogram command. Additionally FIND/READ statements may be used in combination with the Histogram to eliminate much S2 and L3 processing.

# 15. Format Options

- A. Identical Suppress Allowed in the "DISPLAY" clause only. If the value of the current field is identical to the value of the field in the preceding output line, spaces are moved to field location in the current line and the line is printed.
- B. Empty Suppress If a line is completely blank, it will be completely suppressed. This option will physically suppress an entire output line, whereas, identical suppress alone will not.
- 16. NEWPAGE and EJECT Option Extensions

It is now possible to page EJECT based on a test of an internal line counter. The NEW-PAGE statement now allows a "WITH TITLE" clause.

- 17. New Statements "FOR", "LOOP", "STOP"
  - A. The "FOR" statement allows for iterative loop processing.

- B. The "LOOP" statement closes a processing loop at the point chosen by the user rather than having Natural close the loop with a new loop initiating statement (which is the current situation in in ADACOM).
- C. With the "STOP" statement, the user may now terminate any request at any point in time based on a logical condition.

# 18. READ/WRITE User Files

In batch mode only, any combination of up to 20 sequential (QSAM) user files may be read or written in a single Natural request using the READ/WRITE USER FILE functions. CALL FILE is still supported and is required for files other than standard sequential (i.e., ISAM, VSAM, etc.).

 Multiple Reports in a Single Pass of the Data.

In batch mode only, Natural supports up to 20 output reports in a single request involving a single pass of the data.

# 20. Terminal Mapping

Natural contains its own built-in terminal mapping system which does not rely on any external maps. This mapping facility allows the user to construct a map on-the-fly in a Natural request and then use the map for data entry and retrieval. Prompting is an integral part of the mapping facility.

Implicit with the terminal mapping facility is a line editor facility. Natural has a line editor for adding, changing, and deleting statement strings, storing user requests in the Data Dictionary, copying stored source statements to be included in the current request, etc.

# 21. Compress Function

This function allows multiple fields to be combined into a single field and compressed to remove all spaces between values or leave one space between each. (A useful facility for label creation.)

### 22. Perform Break Processing

Besides the automatic break processing that is done for FIND, READ, HISTOGRAM, and SORT statements, it is now possible to perform break processing anywhere in the program depending on a logical condition. The perform break processing allows for the creation of break hierarchies and the evaluation of standard system functions.

# 23. DISPLAY and GIVE System Functions

This option allows the user to evaluate standard system functions like MAX, MIN, AVER, etc. at the end of every page with the AT END OF PAGE condition.

# DBA Tools Special Interest Group

Finally — as a result of the survey distributed in the latter part of 1978, lists of DBA tools available from or needed by ADABAS users have been developed. A copy of the complete lists has been forwarded to the DBA Tools Regional Coordinators and also those registering on the Group Roster.

# Examples of DBA tools available:

- DBUPDATE general facility to apply updates to ADABAS files executed as normal OS job.
- MPM STARTUP/RECOVERY MPM startup and recovery procedures.
- DB GROWTH MONITOR File growth statistics.
- BUFFER POOL SCAN scans ADABAS buffer pool and displays block usage by file by block type.

### Examples of DBA tools needed:

- Utility program to reorganize data base without a complete unload.
- Method of billing chargebacks when TP transactions are rerun.
- Graphic representation of layout of Associator and Data Storage.
- Improved backout mechanism which is easy to use for operations and available without bringing down MPM.

We now have a good start for a catalog and the capability to provide the users with those DBA tools that are either available or needed. For a copy of the complete lists or specific tool information, forward your request to Software AG - Attn: Steve Greaves.

# Change/Enhancement Status

All Change/Enhancements have been entered into the new ADABAS Change/Enhancement Reporting System (ACERS). The preliminary new Change/Enchancement Report was generated on February 9, 1979. This report was generated with ADACOM in a period of two weeks. This two-week period included installing ADACOM, learning how to use ADACOM, and generating the Ghange/Enhancement Report.

All indications appear favorable for distribution of the Change/Enhancement Report to all ADABAS users prior to the Users' Conference.

# Restart/Recovery Special Interest Group

I have heard several interesting rumors about installations that have automated the Restart/Recovery process. I would appreciate hearing from any installations that have tried this and that would be interested in participating in a panel discussion on this topic at the San Diego Conference. I am sure that your experiences would be valuable to us all. Alternatively, is there any interest in holding a question/answer session on the Restart/Recovery process? Ideally, we would have several experienced users and a Software AG representative available to field the questions. To date, I have not received much response to my request for questions, but all the scuttlebutt I hear indicates that many users are operating with a minimum amount of information. Have you experienced a problem doing Restart/Recovery? If so, send me a note or call, and let me know what happened. I will collect these experiences and present a compendium of them at the Conference. Do not feel that you might create an embarrassment to your company; all material received will be presented anonymously if you desire. There is still time to have a good session at the San Diego Conference, but only if you will supply some input.



# EASTERN CANADA & UPPER NEW YORK REGION

Our third meeting was held on the 6th of March in Ottawa. Twenty-three persons attended, representing 13 ADABAS installations. After the usual introductions we settled down to a users' business session. As allowed for at the last International meeting in Boston, we held an election to determine our next year's Regional Representative. I am pleased to announce that this will be Ted Hillis of Consumers Gas Company. Ted has been very active in the Users' Group and brings considerable experience with him. Consumers Gas was the first Canadian installation of ADABAS. We decided to hold four meetings between the annual meetings rather than only three. Dates for the meetings are as follows: 11th September 1979 in Ottawa, 27th November 1979 in Toronto, 5th February 1980 in Ottawa, and lastly, 29th of April 1980 in Ottawa.

We moved on to an open session in which each installation was free to bring up any items they felt might be of interest to other members. One problem that seems to be common to most users is the difficulty in getting on-line utilities to work consistently. We all seem to experience the frustration of having a utility fail with a condition code 15 when there seems to be no logical reason for it to do so. We would be interested to have some feedback from other user groups to see if this problem is widespread. Another expressed concern was the frequency of distribution of System Modifications. Our users' group would like to see them released every three months. If other regional groups concur, perhaps we could make a case with Software AG to improve this area.

Our main presentation of the day was by Gary Bowers of Software AG of North America. He overviewed for us the major changes in Version 4.1 of ADABAS. It seems that the major changes that will affect most users is the Restart/Recovery area. The changes that have been made here are welcome, but they are not exactly transparent to the user. I urge all users of Restart/Recovery to thoroughly review the ADABAS Version 4.1 Planning Guide (Form ADA-411-001 available now) and decide now how they will handle Restart/Recovery. It is likely that you will want to make significant program changes and, in many cases, you will have no choice. There are many other changes in Version 4.1, but they do not seem to require as much effort as this area does. Our meeting adjourned at 4:00 p.m.

### NORTHWEST REGION

Our last regional meeting before the Annual Conference was held in Vancouver, Washington on March 2, 1979. It was once again well attended with users from Washington, Oregon and British Columbia.

The discussion included presentations from the Washington Data Processing Service Center (3350 conversion, front-ending the SAG Data Dictionary), Washington Administration for the Courts (predicting Data Base Space requirements), Simon Fraser University (a generalized update system) and the Washington State Library Network (loading large files).

This group has become extremely active over the years. I am always amazed at the readiness of its members to speak on any topic at regional meetings and to take presentations to the Annual Conference. It is that sort of support that makes the job of Regional Representative so easy.

Thank you all for another fine year.

### NEW YORK CITY/TRI-STATE REGION

The Fifth ADABAS Users' Group meeting was held on March 7, 1979 at Chase Manhattan Bank. The topic of discussion was Restart/Recovery. A paper was presented by Helen Hirsch entitled "ADABAS Start-up/Recovery Procedures". The paper outlined automated procedures used at Morgan Stanley.

Ed Forman discussed Restart/Recovery under Verion 4.1. Users interested in the topic of Restart/Recovery are asked to get in touch with Bob Taylor of Shell Canada, Chairman of the Restart/Recovery Special Interest Group.

A research form from Jeffrey Hoffer of Case Western Reserve University was distributed to the representatives of the twelve installations attending this meeting. The next meeting will take place early May. A topic and location will be announced shortly.

The March 22, 1979 meeting of the West Central Region ADAGROUP was held at the Host Hotel in Houston. There were 17 attendees representing nine ADABAS installations.

A survey on "Design of Inverted Files" prepared by Case Western University was distributed to all users in attendance. Also a course outline by Mr. Steve Robinson was distributed. The course will be presented in Houston.

A report on the Executive Committee Meeting was given by Charles Rolls. The following items were of most importance to the users present:

- Change/Enhancement Request Procedures will be made and distributed to each user in the region. Our thanks to Don Skwarcan for his efforts.
- Changes to the ADAGROUP Constitution and By-Laws: A copy of the existing constitution and a copy of the proposed constitution will be forwarded to each user in the region. The general comments were favorable. There was some discussion about revised regions.
- 3. Customer Problem Reporting Procedure: This was by far the item of most importance. The general consensus of opinion was that Software AG was still falling considerably short in this area. We discussed alternative approaches to bringing this problem to Software AG's attention and reaching a solution prior to the Annual Conference. Concern was voiced that the debug feature offered to Com-plete users might actually lessen the already poor response from Software AG to non-Com-plete users.
- 4. The potential merger of ADAGROUP with the Com-plete Users' Group was discussed. General comments were favorable.

Two special presentations were given by users. Mr. Bob Henley of Gulf Oil gave a presentation on Gulf Oil's approach to multiple data bases. Mr. Bill Thornton of Superior Oil gave a presentation on Superior Oil's Data Administration and Planning Charter. Both presentations were excellent and hopefully set the trend for additional presentations.

The Change/Enhancement Requests were discussed and each user present indicated the five or six enhancements of specific interest to them. We also attempted to determine if there was a preferred approach within our group for these problems having several solutions offered.

Our next meeting was set for July 19, 1979 in Dallas. It follows shortly after the Annual Conference to allow continuity of any actions initiated at the Conference.

# **Houston Users Meet**

Why would representatives of 9 petrochemical companies meet in Houston for lunch? To set oil prices? Not quite. Thirty-five people recently gathered at Trader Vic's restaurant for a meeting of local Software AG clients hosted by Tom Berrisford and Software AG. The Houston area users of ADABAS gather every month or two to discuss mutual interests over lunch. This meeting was highlighted by a discussion of the software industry - past, present, and

# Reston Acquires Own Computer Facility

In March 1979, Software AG of North America, Inc. decided to build and install a computer center. We are in the final implementation phase of installing this center, which will be used primarily for developing and testing our software products; and will include the following equipment:

- (1) 370/145 2MEG CPU
- (1) 2540 Card READ/Punch
- (1) 1403-N1 Printer
- (9) 3330 Model II Disk Drives
- (3) 3420 Tape Drives
- (1) Memorex 1270 Communications Controller with 8 TTY Dial Ports and 8 Bisync Ports

Concurrent with the implementation of this new facility, we are changing all of our remote 3270 terminals to local terminals. Additionally, we will be installing 3270 CRT's in individual offices to improve the productivity of our development personnel.

Initially, our production operating system will be OS/VS1. For testing purposes, we also plan to generate DOS, DOS/VS, DOS/VSE, OS/MFT, OS/MVT, OS/SVS, OS/MVS and VM. During non-production hours, we will schedule test time to test these additional operating systems in either stand alone mode or under VM.

Our computer center is expected to be fully operational in May 1979 and we will be offering a limited timesharing service to: existing users of our products; new users; and prospects. This facility will be offered through either a batch RJE facility (like Data 100) or online interactively through Com-plete's program development system. The online program development facility is accessible via TTY or 3270 compatible terminals. If any of you are interested in using our facility, please write or call me at (703) 860-5050.

This computer center will give our development people a resource which will accelerate future development and improve service to our users.

# Overview - General Overview of VTAM Support and Enhancements

Don Crawford, Com-plete Development Staff Software AG of North America, Inc.

IBM has designed VTAM to be used as a Software front-end to any software package (such as TSO, CICS, CRJE or Com-plete). VTAM handles most line control problems which does remove some coding problems on the part of the application program. NOTE: "The Application Program" in this case means the application program from VTAM's point of view - e.g., TSO under Complete, of course, the functions of TSO, CICS and CRJE have always been handled in one terminal network.

All current Com-plete application programs will continue to run under VTAM just as they have with Com-plete native terminal control. Com-plete application programs with special writes (i.e., CALL "WRTSEC" USING. . .) will naturally have to run on the same type of device under VTAM.

Com-plete will use VTAM just like any other VTAM application program. Com-plete will open an ACB to identify itself to VTAM and process data using SEND and RECEIVE macros (to SNA devices such as the IBM 3767) and READ and WRITE macros (to non-SNA devices such as teletypes.)

Com-plete will allow a terminal or logical unit to be defined either to Com-plete (using TIBTAB) or to VTAM or to both. If VTAM controls the terminal, the terminal operator will be able to log on to any software system that is allowed, including Com-plete.

An installation can choose one of the following methods if using a terminal with VTAM/Complete:

- 1. Com-plete Native Only. The terminal is defined in TIBTAB, but not to VTAM. A 370X EP GEN is required for remote terminals; only a UCB is required for locals. This option is the same as current support and has much less system overhead, especially for
- 2. VTAM Support. The logical unit can only access Com-plete through VTAM support. A TIB may be defined in TIBTAB with the VTAM option or a TIB will be created when a VTAM terminal logs on to Com-plete. The

VTAM logical unit may be logged on to Com-plete because of a terminal operator initiated LOGON command, a VTAM operator initiated VARY LOGON command, or because Com-plete is defined as the controlling application for the logical unit. If a TIB is predefined, a logging on VTAM terminal will always have the same TIB. Because the same TIB is acquired each time, options specified in the TIB, e.g., screen to hardcopy, will remain the same for the VTAM logical unit. When Com-plete is started, it will attempt to connect every logical unit that has a predefined TIB. If a logical unit cannot be acquired, it will still be attached to the predefined TIB when it logs on.

Either Native Com-plete or VTAM Support.
 The choice is under control of the computer operator using the Com-plete OC commands IGNORE/DELETE/ADD/RE-START and the VTAM VARY command. This option is only available for local terminals since control of a remote line is handled by NCP.

Com-plete will support devices that are supported by VTAM. Each type of device will require a Complete data module. Expansion space is left in Com-plete to allow these new data modules to be included without a new release of Com-plete.

Com-plete will take a Com-plete user exit for each VTAM to Com-plete user exit (such as the VTAM LOGON and RELREQ exits). Com-plete will also take other user exits as appropriate. Com-plete will allow the user exit to override any decision that might be made either implicitly or via other user specifications, such as on the TIB. The user exit is passed the address of the TIB as well as data that comes from VTAM. For example, if another VTAM application program requests a logical unit that Com-plete owns, VTAM will enter Com-plete in the RELREQ exit routine. Complete will determine whether to release the logical unit based upon the TIB parameter VTAM =. If VTAM = (..., RELLOGOFF, ...), the logical unit will be released when the Com-plete user logs off unless the user exit overrides the decision.

Several new features will also be included with VTAM support. These new features include:

 Better support of terminal device format characteristics. Com-plete will keep four new fields for each terminal — the permanently and currently assigned terminal line length and number of lines. The \*ULOG utility can be used to change the current format. For example, if a shop has dial-up ports, the default for the ports (TIBS) could be the more common line length and the uncommon line length users could use \*ULOG to modify the line length according to their device.

- Com-plete Terminal Name. Each terminal will be able to have a terminal name of up to eight characters (restarting with a letter). This name (and the group names) will be used by the extended OC command support and by the message switching and print out spooling facilities. If the terminal (logical unit) is running under VTAM, the terminal name will be the VTAM logical unit name.
- Consistent Group Name Processing. The tables TTOCTL and TTMSRO will be replaced by a common table (group table) that is built using the TIB macro. These tables will be used by the Com-plete OC commands and by message switching and print out spooling. When a TIB is defined, the groups that it is to belong to are specified in the NEW GROUP = parameter of the TIB macro. The table is built automatically by assembling TIBTAB. TIB names will be searched before group names.
- GETCHR Function Extensions. The GETCHR function will be extended to include whether the TIB is controlled by VTAM or not. The Com-plete terminal name or VTAM logical unit name will also be available. The old 3270 name formats are emulated if required.
- Better error handling in several device modules (such as teletypes).
- An application program may be automatically started whenever Com-plete is started.
   This will allow a user to design application programs that are automatically restartable when Com-plete is restarted.
- Better handling of terminal independent writes.
- Extended WRITE special features in 3270 type devices.
- Enhancement of the IGNORE and RESTART OC commands to include addressing a terminal or line by LID, CUU, USERID, COM-PLETE TERMINAL NAME or VTAM LOGI-CAL UNIT NAME, or COM-PLETE GROUP NAME.
- Addition of the Com-plete STALL and UN-STALL OC commands. These commands have the same operands as IGNORE/RE-START. STALL will not log off or disconnect a terminal. Input will not be accepted during a stall, but all threads will continue to run until the ready to run queues are exhausted. Messages will not be scheduled to a stalled terminal. UNSTALL will unstall a stalled terminal.

# On-Line Access to Easytrieve Macro Library

Jack Plowman Evans Products Company

We have recently provided our users the ability to access the EASYTRIEVE MACRO library from Com-plete. The requested macro is read from the EASYTRIEVE library, and placed in an SDFILE in \*UEDIT's format. Control is then passed to UEPDMN (\*UEDIT's workhorse), and the user is on his merry way. The \*UEDIT command exit (UUEEX2) traps the SAVE or SUBMIT command, and transfers control to routine that submits the workspace to batch for the actual update. We could have updated the library at this point; however, we chose to avoid dataset integrity problems by not providing the on-line update function—yet. We will probably be required to provide this function sometime in the future.

# \*ZSDF — Extended SDFILE Utility

Jack Plowman Evans Products Company

This utility was written before \*UDSDF was available and we have decided to keep it around for awhile. The program has full-formatted display capabilities. The user can begin displaying at any point in the SDFILE, and can scroll forward or backward at will by using function keys. He can also skip to any record in the file, and can even follow the forward/backward chain pointers that \*UEDIT uses.

The ZAP function allows programmers to alter their SDFILES and continue their programs or rebuild their SDFILES, sometimes saving many hours. An interlock is provided to prevent non-control users from ZAP-ing an SDFILE that is in use by multiple users.

The print function will print the current record on the requested terminal(s) or on the user's default hardcopy (SCHC) terminal.

We are working on a COPY function that will allow changing file size or record size while copying.

The program uses mapping and currently only supports 3277 type terminal, but could be upgraded for other device type very easily.

I would like some volunteers to try out this program as a "BETA" test prior to putting it on a tape for general distribution. Just give me a call at (503) 222-5592 and I will mail you a tape.
