## NATURAL DB2 Update

At the time of this writing, November 29th, NATURAL DB2 V1.3.1 has been shipped to several beta sites. Assuming all goes well, the official release date is now in January. At this time all customers will

receive the NDB V1.3.1 tape, the new NATURAL DB2 and SQL/DS Users Guide, and the Release Notes. This version of NDB has been tested with NATURAL SM4, (base and both the fix tapes), and also with NATURAL SM5. It is the released version of NDB V1.3.0 that many customers are now running, which features the SYSDB2 utility for the DBA, and Static Support for one application plan per execution of NATURAL. NDB V1.3.1 can run under TSO, (online or batch), CICS, and IMS/DC.

By Christmas the next release of NATURAL DB2 will already be installed in a few pilot installations.

It requires NATURAL SM5 as a prerequisite, and features as the major enhancement, support of the SQL SELECT statement from within a NATURAL program. In the program, the programmer can now choose, (when accessing DB2 or SQL/DS) to code a NATURAL FIND or READ statement, and have it translated to a SELECT, or to directly code a SELECT statement. The implementation method is that SELECT is functionally equivalent to FIND or READ in that it starts a NATURAL loop, and must be terminated with an END SELECT statement. The programmer does not have to worry about handling DB2 'cursors', since NATURAL will pass data back a row at a time, as normal. Syntax checking of the SELECT statement is performed

This will allow people that didn't get to go to the conference the ability to hear some of the presentations. This will take place some time in January or February.

We hope to culminate this project with an "International Year" theme at next year's Software AG conference in San Antonio, where the international area and regional representatives can meet to plan further details of establishing closer ties with each other. # ELITE Has Been VAX-inated

It's finally here! NATURAL ELITE is now available for the VMS customer. NATURAL ELITE (VMS) is Software AG's computer-based training system, designed specifically for the VMS customer. ELITE is an acronym for Effective Learning in an Individual Training Environment.

## Basic and Extended Packages Available

NATURAL ELITE (VMS) is available in two different packages. The basic package includes the Administration and Presentation systems, while the extended package includes the Administration, Presentation, and Authoring systems. Both packages allow students to register and take courses.

With the Administration and Presentation components, you may take courses and be tracked and scored. The Authoring feature not only allows you to take courses, but also to develop your own. For example, you can develop courses which teach employees how to use systems specific to your industry, such as:

- Communications hardware and software
- Accounting software
- Computer hardware and software

## ELITE (VMS) Differences

NATURAL ELITE (VMS) is very similar to NATURAL ELITE for the IBM. However, there are some differences that make NATURAL ELITE (VMS) unique.

1. Throughout all of the courses, you will see references to PF-keys 1, 2, 3 and 12. Within the VMS environment, you will need to use your equivalent GOLD keys. You should contact your training administrator to find out which are the GOLD keys for your keyboard.
2. When editing or creating a map (screen) in the Authoring component, you must *always* clear your work area (function code X) before you begin. You could

have another map in the work area and might edit the wrong one. After submitting the CLEAR SOURCE AREA command, be sure you receive the following message: WORK AREA HAS BEEN CLEARED.

3. NATURAL ELITE (VMS) runs on VMS NATURAL 1.3.

How to Use ELITE (VMS) and Introduction to NATURAL (VMS) are the only courses currently available for NATURAL ELITE (VMS). ADABAS (VMS) Fundamentals is presently in beta test, and development on SUPER NATURAL (VMS) Fundamentals is scheduled to begin soon. Below is a brief description of all VMS courses.

## How to Use ELITE (VMS)

How to Use ELITE (VMS) teaches the student all aspects of using ELITE, including:

- Accessing and using ELITE
- Student registration and course administration
- Course development

This course is accompanied by a Student Guide, which includes exercises and solutions designed for students to gain practical knowledge.

## Introduction to NATURAL (VMS)

The Introduction to NATURAL (VMS) course teaches the commands, statements, and proper syntax required to write NATURAL programs ranging from simple to complicated and integrated. This course also includes a Student Guide which provides exercises and solutions to reinforce what the student has learned.

## ADABAS (VMS) Fundamentals

ADABAS (VMS) Fundamentals is designed to introduce the student to the ADABAS data base environment by explaining the following ADABAS-related functions;

- Definition of a DBMS
- Data compression
- Data formats
- Data storage

- Data definition modules

Because students cannot directly access ADABAS, this course does not include a student guide.

## SUPER NATURAL (VMS) Fundamentals

SUPER NATURAL (VMS) Fundamentals is designed for end-users who will be using SUPER NATURAL (VMS), a report generator. The student is introduced to both FIXED FORMAT and FREE FORMAT modes. The course will include a Student Guide with exercises using SUPER NATURAL.

before it is passed to the DBMS, and the stated support is for the ANSI standard SELECT, plus applicable IBM extensions.

Other enhancements included are: the ability to switch application plans while NATURAL is running in the IMS/DC and CICS environments, support for the FIND UNIQUE statement which will translate to a form of the SELECT statement which retrieves one row only and does not use the FETCH statement internally. The purpose of this is to provide relief from some usability problems which have been reported when DB2's referential integrity is being used.

Finally, while not an NDB release, I should mention that PREDICT 3.1 which was demonstrated at Anaheim, provides support for DB2. PREDICT can now be used to keep the elementary definitions which make up the DB2 tables, views, and databases. DB2 tables and views may be generated from PREDICT, or existing tables/views can be incorporated into PREDICT. There is also a comparison facility, between information on the DB2 catalog and PREDICT.

# Database Functional Area Representative Report

This is my first opportunity to write to you since the Anaheim conference. I felt, like many of you, that this was probably the best Software AG International Conference to date. I was pleased to meet many of you at the conference and discuss your concerns and needs in the area of Database Administration, specifically with the use and performance of ADABAS.

As mentioned to many of you at the conference, we are in the process of placing ADABAS Version 5 into production in a phased approach. We are using the Migration Aids Facility to alleviate the problem of an all or nothing situation between ADABAS Version 4 and ADABAS Version 5. We are obtaining outstanding results with our testing of the ADASAV Dump Restore Facility under Version 5. At the time of this writing, we have dumped our 10 Pack Tridensity production Database under Version 5 in approximately 60 minutes using the DRIVES-3 command in ADASAV. We were able to restore the same Database back to the full 10 Tridensity Packs in 52 minutes using the same multi drive approach. Therefore, all is going well with our evaluation of ADABAS Version 5 and we expect to be in production by the time that you read this newsletter article.

Software AG is planning on allowing us to review and test the Centralized Security Interface. More specifically, we are planning on evaluating the Top Secret component of the Centralized Security Interface. This very important area is moving exceptionally well within Software AG and we expect to have ADABAS under Top Secret control in the very near future. We will let you know in a subsequent article how the interface testing proceeded.

Many of you attended the ADABAS Performance and Tuning Session which I presented at the conference. I spoke with several of you after the presentation on your specific tuning questions and concerns. Please feel free to call me at any time to discuss your performance concerns and considerations, whether you are in production under ADABAS 5 or under ADABAS Version 4. I would be happy to assist you in your performance and tuning concerns. Presently, as mentioned above, we are very pleased with many of the areas under Version 5 that we are testing prior to our implementation into production.

In a preceding newsletter, I asked for several volunteers to fill the various vacancies within the Database functional area. I am pleased to announce that several of you have come forward and have volunteered. Christine Georgilas of Mitre Corporation has been appointed as our new Database Tools Coordinator. At the end of this newsletter article, I will pass along all names, addresses, phone numbers and FAX numbers as I have them to date for the newly appointed representatives. Christine should be contacted if you have any tools that would pertain to ADABAS in general. She and I have chatted and her plan is to produce a new tools tape which would encompass ADABAS Version 5. Presently, I am debugging several User Exits for Version 5 at our location. Most specifically, ADABAS User Exit 2 which processes dual PLOG and CLOG data. It is my intention that we will be providing this on the DBA Tools tape when properly debugged. Also our Exits are being written so that they take full advantage of 31 bit addressing, as well as running above the 16 MEG line.

Larry Rauch has taken the large Database SIG position. I thank Larry very much for filling this very important SIG and we should be hearing from Larry as the large Database users contact him with their concerns and advice in the large Database arena.

The TAC's are being filled by several volunteers who came forward

during the Anaheim conference. Etem Dolem of BP Exploration, Inc. has accepted the TAC position of CICS ADABAS interface. Dan Burger of Gold Bond Building Products is our newly appointed ADABAS Review TAC. Jim Crystal of American Family Insurance has accepted the NET-WORK/ADANET TAC position. I am pleased to have these people coming forward and volunteering for these very important areas. Presently, I have several vacancies. I need TAC's for the following areas:

- ADABAS VSAM BRIDGE
- ADABAS DL1 BRIDGE
- ADABAS TOTAL BRIDGE
- ADABAS IMS/DC INTERFACE
- ADABAS TSO INTERFACE
- ADABAS REFLECTIVE DATABASE
- ADABAS TEXT RETRIEVAL
- and ADABAS CONVERT.

If you have any interest in being the representative of any of the above products, please feel free to contact me. It is not an exceptionally time consuming position, however, it does provide me with knowledge about products that I am not fully versed in and also provides us information as these products evolve.

We are planning to move more quickly on the ADABAS Future's Panel. This is a group of people who can volunteer their time to review future design considerations of ADABAS which would be sent to us from Software AG prior to its release. This allows us as a user panel to provide our input to Software AG about their proposed plans in any number of products related to ADABAS or features within ADABAS itself. This is an exciting panel which can offer valuable information back to the developers. If you have an interest, please contact me and I will sign you up. Other panels are working quite effectively within some of the other functional areas and I wish to have it become an effective panel within the Database arena.

I hope to hear from you soon on any number of the above topics or if you have any questions or concerns in general, please do not hesitate to contact me.

## Administrative Product Representative

The 20th Annual Software AG Users' Conference is over and we are all back in our offices pushing through the piles of work which stacked up and was waiting for us when we returned from California. So, what is new in the Administrative Functional Area? Well, there was exciting news announced at the conference, especially on the NATURAL Engineering Series. I will recap some of the new products and their current status for those who were unable to attend the conference or for those who were torn among the ten concurrent tracks. We had to make some difficult decisions on which presentation to attend and which one to miss! Next year before heading south to San Antonio, Texas we should devise a way to clone ourselves so we can attend all the informative presentations which fall into our areas of interest and cover the products we support.

First, and foremost, was the inspiring news on PREDICT CASE (PCA),

Software AG's Computer Aided Software Engineering tool which is the centerpiece of the NATURAL Engineering Series. What is PREDICT CASE? To summarize, it is a mainframe repository within an integrated application development environment, based on an object-oriented database management approach. PREDICT CASE includes:

- Object and set level repository maintenance
- PC Workstation based diagram generation and editing
- Schema Generation
- Program Composer
- Documentation generation facilities

Additionally, PREDICT CASE integrates all information captured during the development process and provides the user the ability to "navigate" the repository data model to view user specified information, or in other words, customized models. PCA is a sophisticated, comprehensive tool which addresses business requirements throughout the entire System Development Life Cycle (SDLC).

There were several presentations on PREDICT CASE and the NATURAL Engineering Series. Jim O'Leary, Software AG of North America and Wolfgang Martin, Software AG, Darmstadt, both did a great job in communicating the strategic goals of CASE and Software AG's direction on the new technologies which can be used for the development and implementation of corporate-wide information systems. In addition, Software AG responded to IBM's A/D Cycle. Software AG is currently positioned to address CASE tools and System Development Life Cycle today with existing products, while IBM talks about futures. PREDICT CASE was demonstrated in the conference demo room to standing-room-only crowds all week, unveiling Software AG's premier CASE tool.

Sue Lombardi and Pamela Howe, Software AG, North America (Denver), gave a very interesting presentation on CASE application development. Both Sue and Pam have worked extensively with the two American PREDICT CASE Beta sites, Washington State University (WSU) and British Petroleum Exploration (BPX), and presented

"real world" experiences with PREDICT CASE and the strategic direction of the product. Greg Hagan, Software AG of North America, PREDICT CASE product manager, made multiple presentations on PCA and also made himself available to all PREDICT Special Interest Group sessions and the data dictionary workshops to answer any PREDICT CASE questions. (Greg published an interesting article on PREDICT CASE in the September 1989 issue of *Connections*, Vol. 14, No. 3, Page 1).

Dr. Jim Thoman, Software AG of North America, gave a presentation on building applications using ISO-TEC, the methodology of PCA. Dave Wells, WSU, and Patti Piccola, BPX, gave a joint presentation on developing applications using PREDICT CASE. WSU and BPX were the two American Beta sites and these individuals gave an open and comprehensive report on their Beta experiences. (Both WSU and BP Oil, London, have purchased PCA.)

One of the more colorful presentations on PCA was given by Wolfgang Martin and Guenther Mueller-Dorn, both Software AG, Darmstadt. The presentation delivered the message with both humor and a "real world" analogy, comparing PCA with the complexity of making an international business trip. Sound unusual? This was one of the most unique presentations ever delivered at a Software AG conference. For those of you who missed this particular presentation it was exceptional. If you are interested in purchasing a tape the presentation was PREDICT CASE: Planning and Organizing the Application Software Development Cycle (N3).

Debuting in the demo room was PREDICT Version 3.1, demonstrating new, sophisticated functionality, including both User Defined Entities (UDEs) and support of PREDICT Application Control (PAC). At editorial deadline (Nov. 20, 1989), both PAC and UDEs are selectable items. If you are interested in either product, contact your local Software AG office for pricing and release dates. User Defined Entities (UDEs) provide the ability to create additional user-defined entities. User Defined Entities will have 24 keywords, each with extended descriptions and short comments. A UDE can be defined as a 20 byte Alpha/Alphan-

umeric field. The dictionary user can define UDE relationships with any other PREDICT entity (either a SAG or a user defined entity except for elementary fields due to addressability). The UDEs work as normal with PREDICT maintenance, all functionality is available: add, copy, modify, edit description, edit link, etc. A UDE can be connected to 50 other objects.

The PREDICT Application Control System provides a controlled environment to ensure the integrity of an application throughout its life cycle from development through testing and into production and then from production to maintenance. PAC was also demonstrated at Anaheim and many positive comments were passed along to me in hallway conversations. BPX will be Beta testing PAC and will report on the product in the Administrative FAR report following completion of the Beta test.

### Tips

Tip #1: (by Darrell Davenport, Lew Levy, and Veer Pawate)

If you ever wished more than one help routine could be defined for a field on a map, then read this tip—there is a way!

1. Define the HE parameter at both the field and statement level;
2. At the field level define the help routine as a text constant (HE = 'help-rtn');
3. At the MAP/INPUT level define the help routine as a variable (HE = #help-rtn);
4. The field level help will be invoked automatically when the help character is entered (default is '?');
5. The field level help can be invoked manually by using the REINPUT USING HELP MARK \*field statement;
6. The MAP/INPUT level help will be invoked automatically when the help character is entered in a field with no help routine defined (not recommended);
7. The statement level help can be invoked manually by using the REINPUT USING HELP statement (note the absence of the MARK clause);

8. To make the statement level help dynamic set the #help-rtn variable before the REINPUT USING HELP statement;
9. When either version of the REINPUT USING HELP is used (MARK or no MARK), the use of STACK TOP FORMATTED prior to the REINPUT will allow you to pass data to the help routine (passed data can include data from the screen, a text message, message number, subprogram name, etc.);
10. A help routine can check \*DATA to determine if data has been passed (IF \*DATA > 0 INPUT #data);
11. Remember that a help routine can not call another help routine, but can de CALLNAT's and INPUT USING MAP's.

Tip #2: (by Darrell Davenport and Lew Levy)

When stacking data, there are a few efficiency and program size issues involved. Stacking numeric data adds overhead to the INPUT process as NATURAL has to include a sign byte and check for non-numeric data. All variables placed on the stack should be defined with an alpha format, be kept to a minimum, and be input with the IP parameter set to OFF (each variable being input has the input prompt and attribute definition compiled with it and needs to interpret the attribute definition at compile time). Remember: a group field does not count as one element, but as the total number of elements in the group (same with arrays).

In conclusion:

1. STACK only alpha fields;
2. INPUT all fields with IP = OFF;
3. STACK many fields as one large alpha field (redefined);
4. Don't STACK group fields.

It was mentioned that the SVC will change over the next few releases of ADABAS because of ongoing NET-WORK development.

Software AG has started using the database to issue behind the scenes calls to perform certain functions in NATURAL. Specifically, NATURAL itself can issue an E.T. This has caused some users to experience RSP 9's and RSP 21's. Software AG said they will be doing more and more of this to add functionality to NATURAL. There will be something put out to all users explaining when NATURAL issues E.T.'s.

Support for "MOVE INDEX" and "+ Variables" will continue through NATURAL 2.1.6. There is a Change/Enhancement by Boston University that will probably go into NATURAL 2.2 to do a Define Data Dynamic on + Variables at the start of the program. The recommendation of the Product Developers is to start moving + Variables to the beginning of your programs now.

There is currently an open issue about whether + Variables should continue to exist across Logon areas like fields in your GDA.

The issue with "MOVE INDEX" is whether or not to keep the statement. In NATURAL 2, capabilities exist so you don't have to use "MOVE INDEX". Jim Wisdom, Application Development Functional Representative, mentioned that he sees a use for "MOVE INDEX" in dynamic array processing which NATURAL currently does not support.

"MOVE INDEX" and + Variables will continue to be discussed at future Executive Committee meetings. If you have an opinion on either of these issues, contact your Regional Representative or Jim Wisdom. (Addresses are in the back of Connections)

## Tools

Anyone interested in being involved in a NATURAL Tools SIG should contact Jim Wisdom.

There is a new COM-LETE Tools tape available. It includes putting the NATURAL Buffer Pool above the line. Anyone interested in getting a copy should contact Ellen Birch, Communications Functional Representative. (Addresses are in the back of Connections)

## Technical Survey

The results of the Technical Survey showed the largest drop off in the area of Technical Support, especially timeliness of callbacks. The area that showed the greatest improvement was documentation. The next survey will go out in January and you will have until March to get it back to the Technical Survey Chairperson. These results are distributed to those in Software AG who need to get this feedback the most, so please take the time to fill it out.

## Timeliness of Call Backs From Denver

Jim Hill, North American Area Representative, distributed a compilation of notes he received from the Regional Representatives. The #1 issue was the time it took to get a response from Denver on NATURAL V2 logs.

Software AG has come up with a priority system for logs recently. Working with this new method for 3 weeks before the conference cut the number of untaken calls from 350 to 8. Bob Galley, Director of Technical Support, said that Denver's goal is to return every call within 24 hours. I think all users would like to see Bob reach this goal.

## International Area Representative Report

Dieter Storr, the International Area Representative, told us about SAGGROUP in Germany. They deal with the same problems we have. His goal is to begin the exchange of information between SAGGROUP in North America and SAGGROUP around the world. Everyone agreed that this is a wonderful goal, and to work towards that end, the following steps will be put in place:

- 1). Functional Representatives will get in touch with their counterparts overseas and discuss common problems and issues.

- 2). The Change/Enhancement Coordinator will work on consolidating Change/Enhancements from around the world and communicating Software AG's responses to SAGGROUP worldwide.

## SOFTWARE AG

All new product releases go through a "Product Delivery Cycle". Software AG releases a product to about 10% of the shops first. This is called the "early shipment". These users are urged to test the new release to ensure there are no problems. After about a month, Software AG meets to determine if general distribution should proceed. Software AG is currently refining the list of "early users" who do field testing.

A copy of the XA/ESA upgrade policy was sent out to all IBM user sites with VM shops and above. This will also be sent to all DOS users. If you have not received a copy, contact your local Sales office. (Note: All current Products that run under X/A will also run under ESA with no changes.)

An added functionality of ADABAS under X/A and ESA will be to change the Buffer Pool mechanism to not search sequentially through memory anymore. This was done because the Buffer Pool can become so large that you spend a lot of time searching. An indexing approach which uses a 3rd level Caching will allow you to reduce your physical reads by as much as 60%-80%. For some applications, physical reads will all but disappear. This 3rd level Caching will use above-the-line storage in X/A and Dataspaces (if you have a lot of Real Storage) or Hiperspaces (if you have a lot of Secondary Storage) in ESA. Look for more information on this topic to be sent out by Software AG.

Software AG is currently running all products at the most current levels in Production throughout their data center. There is a formal action item from R&D, the data center, and the support group to move releases into Production as fast as they can. This allows the administration of Software AG to become a User of the products like the rest of us. This sometimes causes problems because Denver can't go back to a customer's level,



especially those users who are still on NATURAL 1.2. Software AG mentioned that they would love to get everyone on NATURAL V2 and drop support of NATURAL V1.2. This would allow Customer Support to handle the calls more efficiently. What Software AG does not want is mass panic when they announce the date V1.2 support will be dropped. Be forewarned, that day is coming! It's inevitable. NATURAL V2 is a stable product and I advise you to convert as soon as possible.

Software AG distributed a Customer Satisfaction Survey at the Conference. They will also distribute this to all users once a year. It will go directly to Software AG upper management and will tell them how Software AG is doing as a company in the eyes of their customers.

Software AG will put more into advertising next year. Hopefully this will help them break the mold of being "the best kept secret in the industry."

Software AG will be surveying the user base to determine how many have 3480 cartridge drives to determine the need to distribute releases on cartridges. Currently, if your shop has only 3480's, Software AG will send your release tapes on this medium at no charge. If you have both 3420's and 3480's, and you want your release tapes on cartridges, there will be a copying charge. (Note: Software AG needs 10 days notice if you want cartridges.)

### Documentation

PC emulation on the VAX was not the same for NATURAL 1.4 and NATURAL 1.5. To address this issue Software AG will include the keyboard layout in the documentation.

There are 11 or 12 User Exits in NATURAL. These will be documented and officially available with NATURAL 2.2. All User Exits for all products will be documented in future releases.

An issue came up concerning additional manuals which users purchase that become obsolete within a short time period. Therefore, a policy will be put in place that states if you purchase a manual within a specific period of time

prior to a complete manual change, Software AG will replace it with a current version, *if you call them*. (Note: You will still receive the number of copies specified in your contract.)

### Education

Software AG is currently putting together a NATURAL Internals course. This is something we have wanted for years!

The course "Advanced ADABAS for Programmers" really covers ADABAS Internals for programmers. Software AG took their 3 day "ADABAS 5 Internals" course and asked "how can we teach similar information to programmers?" This course will take care of this.

The course "ADABAS System Design" is a 5 day course covering a wide range of topics including how you would integrate Software AG products to solve a particular business need.

What happened to the "ADABAS 5 Performance and Tuning" class? Is ADABAS 5 so wonderful that it doesn't require any tuning? Sorry, ADABAS 5 does require tuning. Software AG said that 50% of the "ADABAS 4 Performance and Tuning" class was on ADARUN parameters and the rest was on the Command log and design issues. They increased the "ADABAS 5 Internals" class from 2 to 3 days to cover ADARUN parameters. They put specific product design issues back into their appropriate class, and created a 1 day class called "Command Log Analysis" to cover the Command Log.

### Executive Committee Elections

It is always difficult to get people to run for offices on the Executive Committee (and in the Regions). I have never understood this given all the information you receive and the ability you have to present your opinions directly to Software AG management. If you would like to know more about the benefits, call or write to myself, Mary Ellen Woods, Nominations/Elections Chairperson, or Colette Farabaugh, Vice President, and we will send you a letter explaining in detail all the benefits you get from being a member of the Executive Committee. (Addresses are in the back of CONNECTIONS)

Other ways to get involved, without going through the formal election process, is to become an officer in your region or to volunteer to become a Technical Advisory Committee (TAC) Chairperson. There is a TAC for every product Software AG has (over 60 at last count). A list of Software AG products is in the back of CONNECTIONS on the Change/Enhancement form. If you are interested in one of these, contact the Functional Representative who has responsibility for that particular product.

## Need More Space in Your Version 5 Data Base?

Suppose it's 4:30 on a Friday afternoon and your thoughts are leaning toward the weekend. Your manager appears in your doorway and proclaims, "I want you to load this file immediately. I have to run some reports from it before I leave town."

What's the problem, you ask? All users know that such requests must be backed by field definitions and an input data set. So, why the long face?

Staring up at you from the center of your desk is your latest ADAREP—and there just is not enough space on this data base for another large file. Cheer up—it isn't that bad.

You have two options: Either ADD to the data base or INCREASE it. Both options are functions of the ADADBS utility. The ADD should be used if the space will reside on a different device type from where the data base currently resides. This is straightforward and is well-

explained in the ADABAS 5 Utilities manual, so let's concentrate on the INCREASE.

Hopefully, you are not confronted with this sort of emergency often, but it can happen. For that reason, we stress that you execute an INCREASE on your test data base to familiarize yourself with the process.

Let's draw a picture of our current data base.

For purposes of this example, the device type we will use is a single density 3380 with 883 cylinders available for use. Currently, our ASSO is 750 cylinders and DATA is 1000 cylinders. We want to increase ASSO by 250 cylinders and DATA by 500. The "increased area" for ASSO is available on ADA002. We want the increased area for DATA to reside on the new pack, ADA005.

The following steps should be used to INCREASE in an OS environment. NOTE: The procedures for CMS and DOS will be covered in a future issue of *Connections*.

### Step 1

Execute an ADAREP CPLIST to establish a baseline snapshot of the existing data base prior to the INCREASE.

### Step 2

Execute ADASAV SAVE. This is for your protection in case you should need to restore the data base to its state prior to the INCREASE.

### Step 3

Execute ADADBS INCREASE. A change with Version 5 is that you can now INCREASE both ASSO and DATA with one execution of ADADBS.

### Step 4

Execute ADAFRM. At this point, you must allocate and format the increased area. You have only two options where the increased area can be allocated: on the current pack or on a different pack. If you are increasing both ASSO and DATA, the formatting can be done with one execution of ADAFRM.

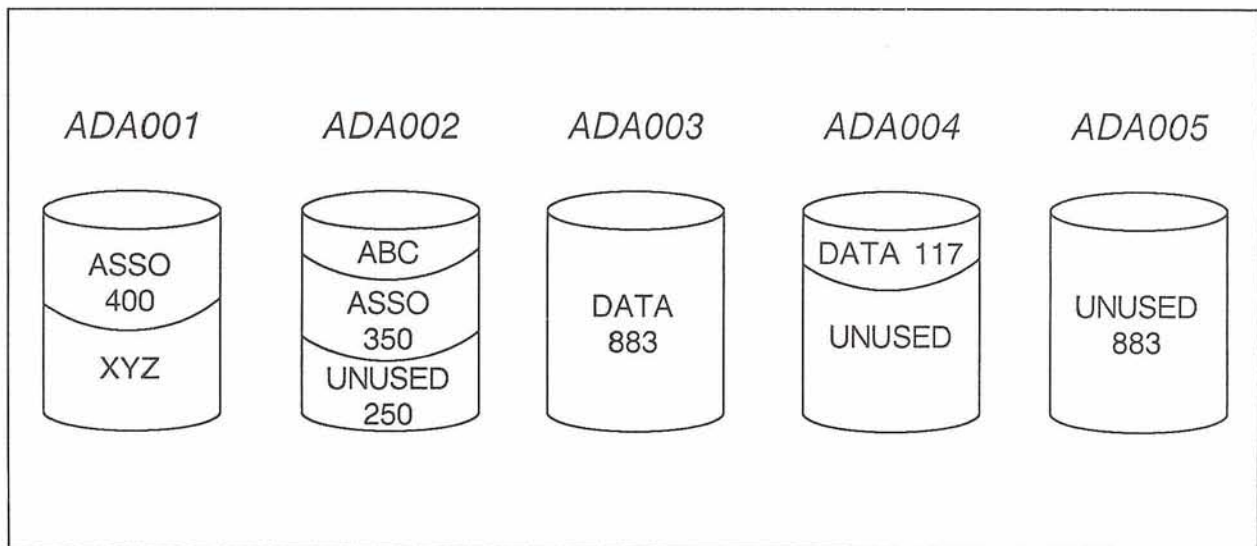


Figure 1: Current Data Base

If the increased area is on the same pack, as with our ASSO example, then the following JCL and Control Cards should be used:

When allocating the increased area to a new pack, as with our DATA example, there are several more steps that must be considered. A new VOLSER cannot be added to the catalog; therefore, the data set must be uncatalogued, the new VOLSER included and then recatalogued. Another consideration is that OS will take the space requested on any pack(s) in the VOLSER list where it is available. As a result, any free space on packs prior to the pack to which you're increasing must be allocated to a dummy data set to force the increased area to the pack where you want it.

In this example, the following JCL and Control Cards should be used:

Execute ADAREP CPLIST to verify that the INCREASE was successful. Pay particular attention to the VOLSER in the Physical Layout of the Data Base to make sure the new VOLSERS are listed and not

## Step 6

Execute ADASAV SAVE to save the INCREASE. This step is not required, but is recommended so that in a recovery situation the INCREASE procedure would not have to be repeated.

Now that we've INCREASEd ASSO and DATA, what about WORK? Since the WORK data set contains information pertinent to a given nucleus session, we need not worry about "accidentally" formatting over existing data during the INCREASE.

Providing the last ADABAS nucleus session terminated normally, you may change the size of the WORK data set. This is done using the ADADEF utility, the NEWWORK function. On the physical side, you need to scratch the existing data set and just allocate a new one with the size that you wish.

# User Exits for SUPER NATURAL Transactions

SUPER NATURAL trivia question: What's the shortest chapter in the SUPER NATURAL User's Guide?

If you answered Chapter 14, Exit Specifications, you win the satisfaction of knowing you are an informed user. Despite the short length of the chapter, however, this is not a trivial subject. User exits can be an important tool for SUPER NATURAL users. If you have ever wondered about possible applications for user exits in SUPER NATURAL or are confused about how to create a user exit, this discussion should enlighten you.

## What is a User Exit?

A user exit is simply a program that is stored outside SUPER NATURAL and is invoked by one or more SUPER NATURAL transactions. This external program can be a NATURAL subprogram or a third-generation language program stored outside NATURAL. We will use a NATURAL subprogram as our example since it is the simpler method of creating a user exit. The same basic procedures would apply to an external program, such as a COBOL subroutine.

If the concept of a user exit is new to you, just think of it as a task that requires an investment of resources that saves you more resources over time. A power tool may cost you more than a hand tool, but you can get the job done faster and even do jobs that wouldn't be feasible with the hand tool. You might need some extra instruction to learn how to use the power tool, and you may need to take it to the shop periodically for maintenance, but it is a good investment. A user exit takes some work to create and implement, but it should save you work in the long run.

Any time you have a need that seems hard to meet using SUPER NATURAL, think about how the job could be done with a user exit.

User exits are useful for repetitive tasks that will be done by many transactions, such as a table lookup. Providing end users with a user exit may save them from having to enter a complicated set of logic statements or calculations, especially if the task must be performed by many transactions.

If one file is always used in conjunction with another, a file user exit can be used to bring necessary data back from the second file in any transaction involving that file. For example, if you have an employee file containing a job code for each employee and a separate table file containing the job title for each job code, you could code a user exit to retrieve the job title from the table file each time the employee file is accessed.

## How Do You Implement a User Exit?

SUPER NATURAL transaction user exits are invoked via a CALLNAT statement for a NATURAL subprogram or a CALL statement for an external, non-NATURAL program. The first step in implementing a user exit is to write the user exit program according to the end user's specifications. The person who codes the program (or NATURAL subprogram) will then provide its name, and parameters to the end user. Once the user exit program has been written, it is simple to specify its use in a SUPER NATURAL transaction using the Exit Specification screen.

As an example, we will create a user exit that will allow us to retrieve an employee's full name using the employee's personnel ID number. By doing this task with a user exit, we will avoid having to do a file link or lookup to the file where the employee's name is stored.

## Writing the NATURAL Subprogram

In order to code the NATURAL subprogram for a user exit, the programmer must know the specifications for the user exit and what data will be passed between the SUPER NATURAL transaction and the exit subprogram.

For our example, we will pass a personnel number to the user exit program. This personnel number is alphanumeric for eight positions. Once the name is retrieved and formatted, it will be sent back in an alphanumeric field containing 25 possible characters. Since this is a subprogram, we have to code a DEFINE DATA PARAMETER statement to identify the two fields passed between the SUPER NATURAL transaction and the subprogram. See Figure 1 for the sample user exit code. This example was written in reporting mode, but structured code may also be used.

The user exit subprogram object module must be stored in the private SUPER NATURAL library ("y-lib") of each user who will specify the user exit on a transaction. (NOTE: If you run SUPER NATURAL under NATURAL SECURITY, you will need to define the "y-lib" to NATURAL SECURITY in order to store the user exit module there.)

## Specifying the User Exit in the Transaction

As the end user, we are told the name of our user exit subprogram, NAMEEXIT, and that we need to pass it two parameters: the employee's personnel number and a field for the name that is alphanumeric for 25 positions.

For our example, we will create a transaction that links the Automobiles and Finance files. We want to create a report that compares Ferrari owners with Ford owners and print each person's name, make of car, net worth, and hobby. We will use the user exit to retrieve the correct full name of each employee from the EMPLOYEES file. Since this file does not contain the employee's hobby, we will use a lookup to retrieve that field from the PERSONNEL file.

Our first step is to make sure we have the correct fields to pass as parameters to the user exit. One of the fields is personnel number. We have OWNER-PERSONNEL-NUMBER on the Automobiles file, but it needs to be put into an alphanumeric field for the user exit. The other parameter is a 25-character name. We have to define these fields using "&" in the function column on two empty lines in the field list. We use a calculation to place the value of OWNER-PERSONNEL-

NUMBER in our PERSONNEL-ID field.

Once the user-defined fields for personnel number and name are available, we type in the EX command to go to the User Exit Specification screen. The first task here is to decide when we want our user exit to execute: at start, before secondary field read, after external/buffer sort, etc. We will do our user exit after the lookup, logic, and calculations, and before the sort. Since we are using a NATURAL subprogram, we mark an X in the NATURAL Subprog. column by the exit number that we want. We enter the name of the subprogram NAMEEXIT under "Program" and mark an X in the Parameter column since we are passing fields to the exit. See Figure 2 for an example.

When we press ENTER, we get a screen on which we can specify the sequence of parameters to be passed. See Figure 3. Once the fields are selected, we can press PF5 or ENTER to return to the transaction screen.

We make sure the rest of the transaction is defined appropriately. See Figures 4 and 5 for the example transaction. When we run the program using RU or PF11, our SUPER NATURAL transaction will automatically invoke the user exit subprogram using the CALLNAT statement, and the information from the user exit can be displayed on the report. See Figure 6.

We could also generate a prototype with the GP command and see how SUPER NATURAL generates the CALLNAT statement to invoke the user exit. You may want to do this to understand better how the user exit subprogram should be coded.

### Advantages of the User Exit

Using user exits can provide many benefits to end users, even though end users may not know how to code the NATURAL subprograms themselves.

- Repetitive or complex tasks can be coded in a NATURAL subprogram and invoked as a user exit, saving the end user time and trouble.

- File accesses such as table lookups can be done in user exits, allowing end users to access more files with one transaction than if they used only file links and lookups.

- Tasks that need to be done each time a particular file is accessed, such as a lookup to the second file, can be coded and specified as a user exit on the file options through SUPER NATURAL maintenance. Then each time the end user creates a transaction to access that file, the user exit will be automatically invoked.

- Any function that is beyond the normal capabilities of SUPER NATURAL may be feasible if coded in a user exit.

SUPER NATURAL users should not overlook the possible uses of user exits in their shops. If user exits can be helpful "power tools," the SUPER NATURAL administrator may want to set up procedures to design, code, and implement them.

All in all, “Windows On Tomorrow” will be remembered as one of the finest of all Software AG International Users' Conferences.



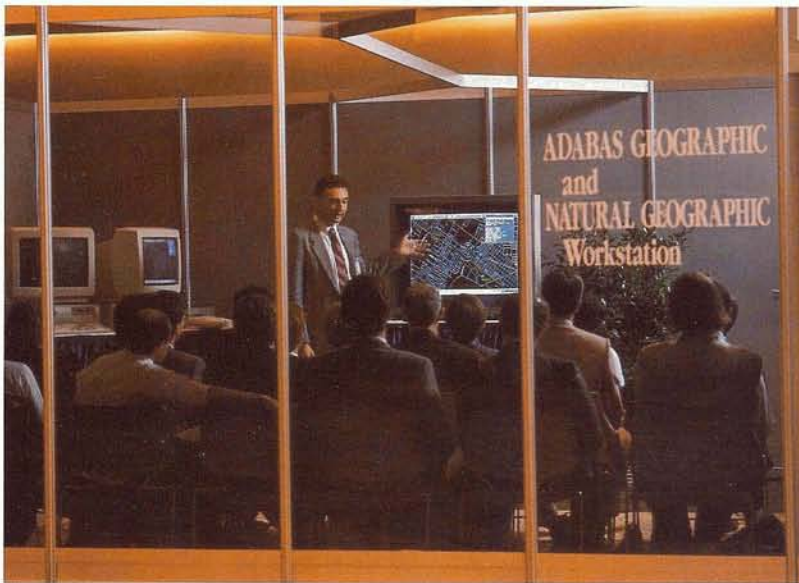

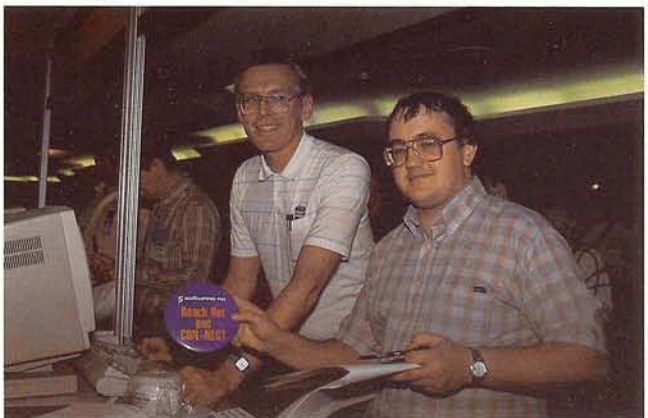

# Creating Forms for Use with CON-NECT 2

Form processing with CON-NECT 2 allows you to automate and quickly process those paper forms that are used frequently in your company. By defining the forms to CON-NECT, you can

- Always have the form available
- Send the form quickly
- Send multiple copies of the form
- Check that your form has been received
- Easily re-send the form if it is erased
- File a copy of the form for quick retrieval

When you invoke the ADD FORM command in CON-NECT, you are presented with the Add Form Definition screen (Figure 1) where you can select one of two methods for defining the form.

## User Form Method

The first method is the User Form. This method allows you to define a 16-line form using CON-NECT system variables, as well as your own variables and text (Figure 2). After filling in the user form, CON-NECT generates the program using the fields and text you specified. The resulting program is stored in the SYSCNT2 library with a name assigned by CON-NECT.

## NATURAL 2 Program and Map Method

The second method of defining a form to CON-NECT involves coding a NATURAL 2 map and program yourself. This method allows you to create a form with up to 20 lines for text and input fields. This method is used when you need to define a multi-page form. Each page of the form is a separate NATURAL 2 map that is processed by one NATURAL 2 program. A sample NATURAL 2 program for form processing with CON-NECT is in Figure 3. The user defined maps and stowed program must be in either the SYSCNT2 library or the SYSTEM library on your FNAT file.

After testing the program and map and copying them into the appropriate library, you enter the ADD FORM command as in the first method. Instead of marking the field User Form, you enter the program name that you created and stowed and either SYSCNT2 or SYSTEM as the library, depending on where you copied your program and map (Figure 4).

## Creating NATURAL 2 Maps and Programs for CON-NECT Form Processing

### General Processing Information

1. The screen (input map) is copied to the editor, and CON-NECT takes care of creating and saving the edit buffer as a document to be mailed.
2. The form program has control over when the screen image is copied. This enables you to do paging in multi-page forms; you must design the logic to do this. Just issue a SET CONTROL 'C' when finished with a given page.
3. One approach to multi-page forms is to use a map of more than 23 lines. With a large map, one SET CONTROL 'C' will copy the entire form to the edit buffer. Windowing commands can be used to page through the map.
4. All lines on the screen or map if larger than one screen display are copied to the edit buffer.

### Writing and Testing a Form Using NATURAL 2 Maps and Programs

1. Develop code in a private or application library.
2. Use SYSMAN to copy the CON-NECT GDA GL-STD to the library or application where the code is being developed.
3. Study the sample form program.
4. Add your code and catalog the program and any maps.
5. CLEAR the edit area.
6. Execute your program.

7. EDIT to see what was created in the edit area. The NATURAL editor will compress out blank lines; CON-NECT will preserve them.
8. Return to Step 4 if you are not happy with the results.
9. SYSMAN program and maps to SYSCNT2 or to the SYSTEM library on your FNAT file.
10. Define the form to CON-NECT with the ADD FORM command.

### Sending a Form

After defining the form to CON-NECT, you can send the form by using the command 'SEND FORM formname'. After filling in the form, you are presented with the standard CON-NECT send screen where you can select addresses and add a cover note to the form. PF5 from the send screen will confirm sending the form, and PF3 will abandon the send function.

### System Forms

If you are creating forms for system-wide use, the form definition should be added in the SYSCNT cabinet. Adding the form in this cabinet creates a form that is available to all CON-NECT users. The DISPLAY FORM command lists all of the forms that are available to a user, including system forms which are denoted by (S). The DISPLAY command also lists the Program and Library names for the modules used as forms.

Additional information on CON-NECT forms can be found in the CON-NECT 2 User's Manual, Chapter 20, Form Handling.

# REGIONAL REPORTS

## NEW ENGLAND REGION

### New Officers Elected

Mary Albano, President, opened the April 28th meeting with announcements. Jim Hill from Washington State University is the SAGGROUP North American Representative. He is looking for a panel of 4 to 5 volunteers to trial SERVICE CONNECTION to ensure it meets your needs and to determine what improvements should be planned for phase 2. The panel will meet at the Conference in Anaheim.

Three-day ADABAS 5 Internals classes offered in May, June, and July in Atlanta, Orlando, and Charlotte were announced. This information was sent to Mary by Clayton Clendinen, President of the Southeast User Group.

A vote was held to determine whether consultants could hold the position of President, Vice President, and Secretary in the New England User Group. It was voted to allow consultants to be Secretary, but not President or Vice President.

#### QUIPS—Questions, Issues, Problems

Often QUIPS are submitted to let other users know about a problem or a solution. If you want a response from the local Software AG office, please provide a log number.

*Jim Wisdom—Boston University:* Will dynamic global variables be supported? Why are they not documented? Are they being phased out?

*Mary Anne Furnald's response:* Roel Pieper has stated in a letter to Boston University on June 5, 1989 that the usage of "+" variables will be allowed in NATURAL 2.1.4 and NATURAL 2.1.5. Fixes to allow this use are available from Denver. No decision has yet been made for NATURAL 2.2.

*Lew Levy:* A NAT0888 can be caused by an error in a parameter list. Field formats are not checked (NATURAL 2.1.3).

Steve Clark said that this problem is fixed in SM4.

*Jim Wisdom—BU:* The L\* variable is now packed in NATURAL 2, although it is documented as unpacked. This can cause a problem if you are passing it to an external routine.

After doing a CATALOG, listing programs (L \*\* ) does not show the new catalog date. This is because the date displayed shows when the source was saved, and a CATALOG changes the object date only. A ".I" will show a single object date, or there are user-written programs to show all object dates.

#### Elections

The election of officers was held. Rick Wahlberg from Brown University was elected President. The new Vice Presidents are Christine Georgilas from Mitre Corp. and Steve Clark from Westvaco Corp. The new Secretary is Susan Giordano of MIT.

#### User Presentations

Paul Schapira from Marshalls presented a case study of the use of SUPER NATURAL and NATURAL CONNECTION. These two products work well together: SUPER NATURAL transactions can be used to download with NATURAL CONNECTION. Downloading has reduced the need to re-key reports.

Jim Buckner from the Commonwealth of Massachusetts spoke on "Performance Monitoring—making Statistics Meaningful." He covered the following points: (1) Reduce data to a reasonable size, (2) Establish contemporary bench marks (profiles), (3) Chart trends, (4) Measures of central tendency—why averages are meaningless for ADABAS Commands—why the median and quartiles are used, and (5) Summarize findings daily.

After lunch Mary Albano thanked the out-going officers, Lew Levy, Linnea Jensen, and Steve Clark. She then turned the meeting over to the new president, Rick Wahlberg.

Eileen Cerbarano and John Guido of Network Solutions and Lew Levy of RPMS spoke on "Putting the Pieces Together—Applications Design using NATURAL 2." An eight-year-old welfare system that was developed in NATURAL 1.1 at the State of Vermont was enhanced and converted to NATURAL 2 for the state of Rhode Island. A system with over 1000 executable modules was created in 6 months. After an introduction by Lew Levy, Eileen Cerbarano covered system navigation. John Guido discussed program design issues.

Rick Wahlberg and Aristotle Ogoke from Brown University spoke on the "Profile of a NATURAL Security Architecture." They described how Brown set out to design a NATURAL Architecture that would: (1) Distribute tasks to end users and developers, (2) Install a security system that is easy to understand and manage, and (3) restrict NATURAL Administrator accounts to members of the Information Resources team.

Jim Wisdom of Boston University presented "NATURAL 2 Administration Issues." He described an on-line system to handle the turn-over procedure.

### SERVICE CONNECTION 1.1.0

Clayton Clendenin of the Orlando Utilities Commission discussed the features of this long awaited product release. SERVICE CONNECTION will be accessible through a dial-in service using Telenet at

either 1200 or 2400 baud. An IBM or IBM compatible PC running MS-DOS will be required for version 1.1.0. An enhancement will be required for NATURAL CONNECTION users to be able to use SERVICE CONNECTION.

System components include:

- Fixes for downloading
- Software AG Bulletin Boards—to include such items as: Customer and Product Support; Customer Training; Distribution; Product Marketing; Tools Tape information
- User Bulletin Boards—to include such items as: User Group Regions; SAGGROUP Executive Committee
- Customer Profile System—This will provide information on your site to other users. Each user will have control over what, if any, information will be available about their installation.

Clayton also demonstrated Orlando Utilities locally written trouble log system. This application is a 'Clipper' application available through the bulletin board.

### Data Center Products

Bob Glasscock, Software AG, discussed Software AG's Data Center Series of products: NATURAL OPERATIONS, NATURAL CONSOLE, NATURAL NETWORK, and NATURAL ISPF. All of these products are based upon Software AG's operating system interface, NATURAL PROCESS.

NATURAL Operations:

- Integration of online production environment
- Integration of NATURAL in production streams
- Analysis of condition codes and sysout
- Analysis of user-defined events
- Use without modification of existing productive jobs.

NATURAL Console:

- Display of Operating system messages
- Logging and filing of messages
- Determination of actions and reactions

NATURAL Network:

- Full control of network
- DBMS information to analyze network problems
- Menu driven

NATURAL ISPF:

- Multiple active sessions (split screen and windowing)
- ISPF like panels

### NATURAL DB2

Lynn Phillips, Software AG, discussed NATURAL DB2. Lynn outlined some very interesting features of this product including automatic cursor management, transparent mixed dynamic/static mode support, and full execution time compatibility between TSO and CICS. Also, there will be full PREDICT support and access to the DB2 catalog in PREDICT version 3.

For those users that have or will be installing DB2 at their site, NATURAL DB2 is a product that should be given a close look.

### NET-PASS

Jim Bando, Software AG, discussed Software AG's session manager product, NET-PASS. Features include a 'Showscreen' function that allows a user to transmit a screen to another terminal, session control that allows a disconnect from one terminal while logging on to another. Jim also discussed Optimize 3270 which performs outbound and inbound message compression, Windows 3270 which allows a user to 'cut and paste,' and Help 3270 that allows NATURAL help features to be used for non-NATURAL applications.

### JES Resource Control

Charles Evans, EPA/UNISYS, discussed a method for controlling batch activity against databases. This technique requires the establishment of a 'resource' within JES, for example, the resource created for the production ADABAS MPM could be '/\*PADABAS'. This means that the only time this job can execute is when the 'PADABAS' resource is attached.



As a normal part of bringing up the MPM, the resource is attached and the resource is detached when the MPM is brought down or it comes down abnormally. This will prevent batch jobs from receiving a response code 148 while the MPM is down.

It is also possible to assign a concurrency value for the resource. That means if the concurrency value for PADABAS is set to 10, only 10 jobs that allocate the PADABAS resource may be active at any given time. This provides a way to 'throttle' batch work through your databases.

### Log Off Loading

Dave Hamacher, EPA/UNISYS, discussed a method for handling PLOG and CLOG off loading for high transaction volume databases. Dave explained that during peak processing periods, the logs would be copied off at a steady rate. If a problem occurred with the offload, typically a tape error, the other log would fill and cause the database to go into a wait state waiting for an empty log.

The technique to get around this problem was to have the initial offload go from the ADABAS Dual log to a temporary data set on disk. When this offload was complete, the ADARES offload job would submit another job that would then copy this temporary log data set to tape. This eliminated the possibility that a tape error would cause the database to stall because by that time, the ADABAS Dual log had already been refreshed and was ready for the MPM.

### CASE Tools

Arnold Carlson, Lykes Pasco Packing Company, discussed the use of Software AG's CASE tools, including NATURAL ARCHITECT Workstation at his firm. Included in the discussion was the use of the NATURAL ARCHITECT Workstation and its associated editors, methodologies for using CASE, and the need to establish proper naming standards.

### Software AG Presentations

Larry Jayne began the meeting with highlights of last year's conference and referred to features of the upcoming conference. He also supplied us with news regarding the next International Conference.

Jack Hauber, Director of Training and Professional Services, Reston office, presented an interesting and informative lecture on "What is Expert Systems?" Jack covered five main issues:

1. Technology and Background
2. Conventional Programs vs. Knowledge Systems
3. Development Process
4. Usage of Expert Systems
5. Environment Expertise and Domain

There is a quick test to determine if the application being considered is a likely candidate to become an expert system. This is the 'Telephone Test'. If I can explain over the telephone what needs to be done, and the person on the other end of the phone can follow my instructions to complete the task, it can probably be turned into an expert system. It should also reduce an action from hours to minutes and there should be a finite number of solutions. This session was part of a full day seminar. If you are interested, contact Jack Hauber in Reston, Virginia.

Barry Warwick, Software AG, Reston office, gave a presentation on the very extensive new features provided by REVIEW. Jackie Albano from Software AG, Reston office, provided a subset of the Physical File Design Class. Each person received a copy of the Physical File Design Class workbook which is normally distributed with the full day class. The lecture has something for everyone. For the less experienced, the lecture provided new points for consideration. For the more experienced user, this refresher course came in handy.

### User Presentations

Next on the Agenda was Diane Brown-Newell from Dow Chemical who addressed the topic of PREDICT Conversion. After going through the PREDICT conversion, Diane shared her insights with us. Some of her tips were:

1. It is necessary to set the defaults through DDA Services before the generate options are used.
2. VSAM DDM's must be contained in a VSAM Database.
3. How to get around PREDICT 2.3.2 not supporting binary superdescriptors.

Last on the Agenda was the user question and answer period. During this period, anyone can ask a question and, hopefully, another user will have the answer or a similar experience. Often, this session alone makes the entire Regional Meeting worth attending. The meeting adjourned at 4:15 p.m.

He also noted that in 2.3.2 certain batch problems with the statistical data report were not functioning properly. Owen said that information relating to PREDICT is available through Tom Visser, PREDICT SIG. His address is in the back of Connections.

He detailed some of the changes that needed to be made to the ADABAS parameters, Utility parameters, JCL (due to the utility changes), WORK dataset, and ADAWAN cards in order for everything to work properly. In addition, he talked not only about the improvements they have seen in the clock time and costs of running batch jobs that use the database but also the ease of maintenance on the database through the new product AOS (Adabas Online Services) from Software AG.

# Ray Young Discusses Features of ADABAS 5

The June 2, 1989, meeting of the Northwest Region was attended by 47 members and guests representing 22 organizations. Topics included presentations and discussions on NATURAL 2.1 Local Data Area Editor, ADABAS version 5, and ADABAS SQL. Presenters included Leo Webb of Washington State's Department of Information Services, Ray Young from Software AG's Denver office and Steve Bradley from Software AG's Seattle office. Guests included a representative from the Rocky Mountain West Region SAGGROUP.

### Networking

The hour between 8:00 and 9:00 a.m. was used to network, revisit with old friends and get settled with coffee, juice and rolls.

Brock Norman opened the meeting promptly at 9:00 a.m. and asked those in attendance to introduce themselves.

### NATURAL 2.1 Local Data Editor

Brock introduced Leo Webb who presented an overview of a class he is developing for his organization. He briefly discussed the three editors (map, program, data) and in response to a question on syntax from the group, noted that all the editors use the same syntax and edit commands.

Leo walked us through steps to create Local Data Areas and Global Data Areas. He discussed how to define arrays and how to break up a field into sub-fields (reference: handout #1).

Leo showed us some of the characteristics and commands within the data editor (reference: handout #2).

## ADABAS 5—Ray Young from Software AG, Denver

Ray discussed differences/improvements of ADABAS 5 compared to version 4. Topics discussed included:

- Hold Queue—restricts programmer to no more than 1/4 of total queue
- Parm definitions and effects on programmers
- Field level changes—floating point format, super/sub-fields, super/sub-descriptors, hyperdescriptors
- Command Enhancements—search, read, update, open/close
- Other Improvements—Space reuse (inverted lists); Buffer flush mechanics (p 25); buffer pool enlarged (header still below 16 meg)
- GET NEXT Processing (p 6)—prefetch invoked at control block level; search criteria optimization; format change translation estimate
- Format Buffer Syntax for record typing (p 8)
- Use of Format Pool/Global Command ID (p 9)
- Search Algorithms—return of algorithm 3
- Soft Coupling (p 18)—Functionality of physical coupling without overhead of coupling lists
- Performance Strategies—increased user defined block sizes, better buffer efficiency; priority of commands; ET blocking

Other topics covered in handout not discussed due to time limitations include:

- buffer flush timing algorithm
- access commands may continue after buffer flush
- change in hold queue manager

Ray specifically recommended using no lower than sm-3 of ADABAS 5 and announced that sm-4 is due out this summer.

After lunch Ray fielded questions of general interest from the group.

- Migration Aids—the general feeling was "avoid"



- If invert goes bad, must restore the file—problem is being addressed
- No more two-step utilities, all one-step
- Checkpoint file—should be considered off-limits, as should all system files

He highly recommends to establish the identity of a data element regardless of where it is. What is the source of the element, who administers or controls the format of data sharing. Also recommends an alias name structure be set up to customize attributes, but maintain the same meaning.

### OPEN FORUM

Jesse Oliverez from US Sprint dis-

cussed PREDICT usage at Sprint. He also commented on a special forum on PREDICT Enhancements to be held with the Software AG developers in Reston, VA on June 22.

Deb Goltra discussed problems found with PREDICT free rules and key words associated with the free rules.

Jacques Hardy discussed ADABAS V4-V5 conversion in production at the City of San Antonio.

Larry Godec from 7Up discussed ADABAS V5 conversion and what to be aware of to avoid pit-falls.

Jeff Schmidt from Software AG discussed tolerance products and the release dates.

Pat LeMoine from Kerr-McGee discussed the features of SUPER NATURAL and how it is used. They have over 400 SUPER NATURAL users.

Jeff Schmidt discussed training opportunities for the Southwest Region. The majority requested Intermediate NATURAL 2 classes.

### NATURAL 2 OPTIMIZER

Mike Day from OXY USA in Tulsa gave the next presentation on NATURAL 2 OPTIMIZER. The following are highlights of that discussion:

- Test showed a 10%-15% improvement in CPU time reduction. There was no noticeable reduction in response time.
- CPU Time Reductions:
  - 10%-20% with online programs that are CPU intensive.
  - 10%-40% with batch report programs.
  - 10%-15% with online programs that are not CPU intensive.
  - 0% with online programs that have high ADABAS access but little processing.
- Natural Optimized object code shows a size increase on order of 20%-25%.
- Should revert to normal compiled code if there is no performance gain from optimized code.
