Las Vegas Conference

The 10th International Software AG Users' Conference was held May 9–13 at the Dunes Hotel in Las Vegas, Nevada. For four days, users of Software AG products attended product presentations, intensive tutorials on product application and usage, workshops hosted by Special Interest Group (SIG) chairpeople, and user presentations.

Highlights of the Conference included guest speakers Capt. Grace Hopper, James Martin and time management expert Dr. Merrill Douglas. Conference attendees also had an opportunity to hear from Software AG of North America's President John Maguire on corporate direction and the need to consolidate the development activities of SAGNA by moving Development from Seattle to headquarters in Reston. Development for North America will be placed in a newly formed Technology Division.

The president of the International Users' Group, Alan Routhier of the County of Sacramento Data Center in California, spoke on the importance of continued user participation and support of SAGGROUP. He emphasized that the Users' Group serves to help users share ideas and information. To be a success it requires active support from all.

The Executive Committee of the Users' Group met throughout the Conference to review the activities of the past year and make plans for the coming one. Topics such as product development, maintenance releases, change/enhancements and future product directions were addressed during the week. Among other items addressed by the Executive Committee: The Southeast Asian Region, consisting of Singapore, Hong Kong, and the Philippines, was formally granted regional status. The

Far East Area's name was changed to the Asian Area, and the Far East Region was changed to the Japan Region. Kansas was moved from the Southwest Region to the Midwest Region. The next Executive Committee meetings will be held the first part of November.







Change/ Enhancement Process Revised

Due to difficulties experienced in the past with the Change/ Enhancement process, the SAGGROUP Executive Committee approved the following revisions:

- 1. A Change/Enhancement Request Form will appear in each issue of the Newsletter to allow users to submit requests throughout the year;
- 2. The deadline for requests to be considered for responses at the annual Conference will be November 30:
- 3. An interim detailed report will be prepared for the fall Executive Committee meeting to give both Software AG and the committee an idea of the nature of the requests coming in.

These changes should alleviate past problems by allowing users to submit C/E requests throughout the year. Also, the interim report will allow Software AG of North America and Darmstadt an opportunity to review the incoming C/Es and assist the Users' Group Product Representatives in consolidating the requestsa difficult and time-consuming effort, Finally, distribution of the ballots for those requests to be responded to at the annual Conference will take place in early December to avoid the mailing difficulties encountered last year.

The Executive Committee also acted on the distribution of the final responses and voting by approving the following:

- 1. Change/Enhancements and replies are company confidential:
- 2. Change/Enhancements and replies will not be published in the Proceedings to the annual Conference:
- 3. Change/Enhancements and replies will be distributed only to authorized licensees of each product.

We hope that the revisions will alleviate previous difficulties.



Eastern Canada Region

Gene Miklovich Systemhouse

On March 30th, 26 users met in Toronto hosted by Shell Canada. The meeting began with a presentation and followon discussion led by Cliff Wietzel of R. D. Nickel on recovery. Cliff made the following points:

1. In a number of cases recovery is designed, or only appreciated, after a failure occurs.

- 2. In the development of a system, recovery frequently is not mentioned as an objective but is implied and represents overhead both to the development and operation processes.
- 3. Most recovery situations can be defined and planned for.
- 4. Design of a system should include the differences between an online enquiry and an online entry system.
- 5. Design may also consider separation of static and volatile data items onto separate files, etc.
- Programs must notify users and/or operators of recovery situations and actions required.
- 7. An operator can effect a restore/recovery process if precise instructions are available.
- 8. There should be an identified person in the DB group as a contact for users, applications or operations.
- 9. When planning for recovery, some of the important points to consider are:
- how long can each cycle be delayed;
- identify length/risk of each phase;
- · list possible failures;
- calculate costs of recovery.
- 10. ET/BT recovery
- needs exclusive control of those transaction items;
- · all or none are applied;
- applicable to small groups of transactions;

- partial transactions are backed out;
- storage of user data with ET is possible;
- · an ET releases records;
- must open with userid;
- if failure is detected by program, a BT may be issued;
- is automatic (only if the database and work are okay);
- cannot work with Cluster at same time;
- cannot backout once ET is issued!
- inappropriate where holding a large number of records.
- 11. Cluster recovery
- appropriate for long lists of records;
- use C2, C3 to identify points of restartability;
- close must be issued on current users;
- if 2 or more programs involved they must checkpoint at the same time;
- checkpoints are automatic by time or number of updates;
- recovery is automatic only if database is okay;
- no simultaneous file use is possible by ET/BT and cluster users;
- there is a risk of backout if program fails because of nondatabase reasons;
- if system fails another program may get control before the first;
- there is no BT command (this is effected by an abend or a forced time out).
- 12. Exclusive use
- no automatic recovery i.e., manual
- no hold logic is done/required;
- ADABAS does not recover.
- In the discussion that ensued, the following points were discussed:
- 13. NATURAL 1.2 Some of the features expected in the next release of NATURAL were:
- · handling response codes;
- · read and write of ET data;
- · full screen editor;
- dynamic definition of OPRB parameters.
- 14. Problems
- Multi User ADAFIX dump of a single file abends when ex-

tended to 2nd reel. Current bypass is to dump in SU mode.

 If a utility receives a response code the step system completion code is still 0.

15. Dual Logging

 automatically switches to alternate logging with no control ensuring log has been copied (this must be controlled by the installation).

16. Security

 Regenerate of entire database requires rerunning security.

17. The User field/Additions in the Control Block is sometimes being set to binary zeroes or

blanks by ADABAS.

The next presentation was by Paul Reino of Shell Canada on their plans to put ADABAS on 3380s. He started by explaining the architecture of the 3380s and their capacity. He indicated they estimated the cost per access on 3380s to be approximately the same as 3350s and it was recommended they be used for online access. Shell also indicated they would be running on a 3081 under SP1.1 and some discussion followed.

- Brian Lee indicated the Assembler/Linkage Editor required a ZAP from IBM.
- Ted Hillis estimated that based on their experience it took 1 hour to unload 1 million records but 6 hours to load and it was advisable to split sort and temp areas. Ted also recommended overestimating size of TEMP, SORT and amount of CPU time. Also consider putting ADALD1 output to tape.
- Brian Lee led a discussion of tuning where a number of topics were addressed:
- 1. in design put the fields most frequently accessed at the front of the record and put NU fields together;
- 2. when retrieving MU or PE fields read the average number of occurrences plus the count;

- load data in primary sequence in which it will be accessed;
- 4. consider doing logical deletes i.e., clear or set key field and delete overnight;
- 5. NATURAL 1.2 with a GDDM graphics interface was in alpha test.

On June 15th, 24 users met in Ottawa hosted by PAC/DSS. The meeting began with a review of the conference in LAS VEGAS. Administrative changes within SAG were announced including moving Development to Reston. The format of the conference was reviewed and an agenda was circulated for reference by those who did not attend. New Product announcements were discussed including NATURAL 1.2 and GRAPHICS, X-IMAGE, COM-PASS, REVIEW and AC-CESS. A question which was raised whether ACCESS was the equivalent of what was known as NATURAL/AF was unanswered and Harry France of R. D. Nickel indicated he would find out.

The meeting proceeded with a review of the new features/ enhancements coming in NAT-URAL 1.2. It was also indicated that it was expected to be available shortly (end of JUNE for tech support) and it was in BETA test at 15 sites, however, none of these are CANADIAN.

Sharon Conners of PAC gave a presentation and demonstration of ADABAS-M at PAC. She indicated they were running on a PDP 11/70 under RSX11-M V3.2 and they were developing their first application. After discussing and illustrating the functions and capabilities of ADABAS-M. Sharon asked Francine Legault to demonstrate this application. Development of a billing system, Francine explained, was proceeding using ADABAS-M and DEC's F.M.S. (screen formatter).

In discussing problem reports, Tom Okrainek indicated a problem testing the RE-GENERATE function under VS1. He indicated Cliff Wietzel of R. D. Nickel was working on the problem. It was suggested Tom

report the problem to Denver to see if anyone else had experienced similar circumstances (Rep's Note: the problem has been reported to SAG under T. L. #39321). ITC inquired if anyone knew whether ADABAS would run under MVS/SP3 (Rep. Note: Cliff Wietzel informs me Version 4 will run with no problem and there are users doing this but that Version 3 will not). Phillip Morelli asked if anyone knew a way of restricting the number of records that can be added by a test application without awaiting for the number of extents to be exceeded. One suggestion was to pre-allocate all DB space thus limiting space available on a file basis, however, it was apparent there was no direct way of having a maximum number of records on a file.

In the afternoon Gene Miklovich reviewed an application system developed almost entirely in NATURAL for the Canadian Electrical Association. The review included discussion on a NATURAL Bill of Materials structure, batch NAT-URAL updates and guidelines for use of NATURAL. A workshop on the role of the DBA followed in which as a group the users profiled their responsibilities. It was apparent that the roles varied considerably with the only almost unanimous role being the running of utilities. It was concluded that the roles depended on the organizational structures in each organization and that the scope that the DBA (group) handled or was capable of handling depended on the size of the group and commitment of the organization to the DBA role. Before adjourning it was agreed that we should meet early September in Ottawa and December in Toronto. (The dates and places will be confirmed as soon as available). It was also agreed to have an Ottawa area picnic July 25th at Vincent Massey Park.

Japan Region 9th General Meeting

Yasuo Shimizu/President Fuji Photo Film Co., Ltd.

The 9th General Meeting of Far East Region Users' Group was held on June 15, 1982 in Tokyo. The number of users increased, and there were 74 attendees from 43 organizations.

The newly selected officers of Users' Group, the activities in the last fiscal year and the balance of 1981 fiscal year were reported and approved by the member companies. The accounting secretary explained the budget, and the officers announced the activities plan for this year. All users approved them unanimously. The Far East Users' Group is planning more active activities this year; for example, the users would like to have joint development and research projects.

Software AG reported briefly regarding the 10th International Users' Conference held in Las Vegas.

In the latter half of the general meeting, Software AG invited Dr. Hideo Suzuki of the University of Tokyo as a guest speaker. Dr. Suzuki presented his thesis on the different ways of thinking between the West (the world of Logos) and the East (the world of Lemma) from geographical, historical and religious point of view. We found it very interesting, and its basic idea would be useful in educating the computer system engineers who mainly deal with things structured logically.

In the afternoon ADABAS/ NATURAL, COM-PLETE and A-AUTO users had their own meetings respectively and discussed detailed activities plans. Also hot technical discussions were held.

Japan Region ASSIGN Meeting

Hiroki Kawamura Nippon Kokan K. K.

I. 30th ASSIGN (the ADABAS Special Interest Group of Nippon) met on April 22, 1982 in Tokyo. 37 persons from 28 companies attended the meeting.

1) The presentations were on the software tools developed by the users. The subjects and the speakers were as follows: a "ADABAS Automatic Recov-

a. "ADABAS Automatic Recovery and Command Log" by Mr. Takahashi, Nippon Kokan K. K.;

b. "ADABAS Operation Tool" by Mr. Kikuya, Fuji Photo Film Co., Ltd.;

c. "Test Supporting Tool" by Mr. Katsura, Nissan Motor Co., Ltd.

2) As for the activities plan, the users requested the items such as described below:

a. Users' presentations on their applications and/or research;

b. Report on the Las Vegas Conference;

c. Presentation by Software AG;

d. Joint research & development (users will form a group(s) to research on their special interest.)

Five meetings are planned to be held in Tokyo during the year and the next one is scheduled on June 15.

II. On June 15, 31st ASSIGN was held in Tokyo. 44 persons from 30 companies attended.

1) Users approved that Hiroki Kawamura/Nippon Kokan K. K. continues to lead ASSIGN as a chairperson, and Mr. Kenji Terada/Kyoko Oil Company was elected as vice-chairperson.

2) Users discussed possibility of joint research and development for this year, such as:

a. Writing ADABAS selflearning book (Pl-method);b. Comparative study of DBMS:

c. Study on the relationship between ADABAS and MVS:

d. Presentation of interface developed by the users.

3) Mr. Juichi Hotta from Fuji Telecasting Co., Ltd. who attended Las Vegas Users' Conference briefly reported the conference.

4) Mr. Masahiro Shimada, Senior Analyst of SAGFE, gave a technical presentation on "ADABAS FUTURE PLANS AND NETWORK" and SAGNA's reply to Change/Enhancement Request reported at 10th International Users' Conference.

5) Mr. Susumu Okoba from JGC Corporation, who also attended International Users' Conference, reported NATURAL Version 1.2 and its future version.

 Each attendee introduced himself and explained his installation's configurations, etc.

Japan Region COM-PLETE Meeting

Yasuhiko Katada/Tokyo Sangyo Credit Association

The COM-PLETE Meeting was held on June 15 in Tokyo. 16 persons from 8 companies attended.

1) The following activities plan for this year were discussed:

a. Presentation on COM-PLETE usage;

b. Technical Information from SAGFE;

c. Technical discussion on specially interested subject;

d. Discussion on Change/Enhancement Requests;

e. Information exchange on effective usage of COM-PLETE;

 f. Exchange of generalized programming tools user developed;

g. Joint development and enhancement of generalized programming tools among COM-PLETE users.

2) SAGFE briefly reported the SAGNA's reply to Change/Enhancement Requests.

 Users gave short presentations on generalized programming tools which they developed. And programming tools provided through International Users' Group were introduced by SAGFE.

4) As users want to know each other for smoother technical communication, the members of COM-PLETE Group decided to prepare a data sheet on their machine configuration, transaction processing system, etc. 5) Next COM-PLETE Meeting will be held in September at Taisei Corporation.



New England Region

Tim McGovern Massachusetts Institute of Technology

- 1. The Boston Company graciously hosted our eighth meeting on April 22, 1982 which was attended by 17 persons from 10 member organizations.
- 2. The following general business items were discussed and/or resolved:
- Our organization should be called the New England Regional Software AG Users' Group, or NE SAGGROUP;
- The next meeting of our organization will be hosted by Alice Schafer at MITRE in Bedford on June 17, 1982. Tim McGovern and Alice will coordinate the agenda for the meeting;
- The nomination and election of the NE Regional Representative for the next year, as mandated by the SAGGROUP Constitution, was deferred until and will be resolved at the Annual Conference in Las Vegas.
- 3. Overlooked past business
- At the December 1981 meeting, Lino Sullivan of the State of Vermont made an excellent presentation on the capabilities of NATURAL for end-product systems development, and we thank him for sharing his thoughts and accomplishments with us.
- 4. Dick Jones of Software AG attended the meeting.
- He comes to us from the Hasbrouck Heights, N.J. office now and was attending to give us the benefit of his technical background and experience;
- We were disappointed to see that the thrust of Dick's presentation was strictly non-technical and was instead a marketing pitch for the Sales, Education and Consulting Services available from Software AG;

- Dick reemphasized that although the SAGNA support for Version 3.2.1 has been diminshed (that is, terminated), customers who have been unable to upgrade will not be slighted in Tech Support:
- Dick announced that the DBA Skills courses have been redesigned, and other courses will be likewise upgraded. The course evaluation has also been upgraded to allow the attendee to evaluate the instructor and the course independently;
- No database design course per se is now available from SAGNA Education and the prognosis for such a course is not bright;
- SAGNA is investigating a variety of alternative educational media other than the overhead transparency, but the near term promises more of the "foil" approach;
- On the subject of on-site education and custom-tailored education, Dick emphasized that "reasonable" tailoring was possible, and that in all cases, the customer has the right to negotiate with the Education office:
- Dick announced the resignations of Senior Financial VP John Okulski and Executive VP Ken Rardin;
- Dick mentioned in passing that the staffing level in the Education area is down somewhat due to the rapid expansion in the last year or so, and that the net profit problems at SAGNA will crimp the expansion required to truly serve the needs of the customer base;
- Dick's final point was a question to the attending members as to how best delineate where Sales Support and Tech Support leaves off and where billable Consulting Support picks up. No unanimous sentiment surfaced, except that the issue is of great interest to the membership.
- Problems and/or displeasures expressed, discussed with Dick:
- Some attendees recounted some serious problems that

- they have had or are experiencing with new products, notably the SM1 of COM-PLETE V4.1:
- The issuance of updates for and correction for the documentation is too sporadic or nonexistent;
- The volume of Early Warnings and zaps which accompany product tapes (be they new versions or SMs) is too great, places a needless burden on the customer and potentially delays possible implementation of the new product tape.
- 5. The Education Committee reported substantial, positive feedback on the most recent Advanced NATURAL Course sponsored by NE SAGGROUP. Other views and news . . .
- Some participants felt that some of the topics covered were of an intermediate nature but that their inclusion did not affect the usefulness adversely;
- It was the consensus that two courses were perhaps derivable from the existing syllabus, one which would be an Intermediate or Advanced NATU-RAL Programmer level and one which would address NAT-URAL functionality from the point of view of the DBA's traditional concerns;
- The scheduling of another Advanced NATURAL course will be postponed until we as a group evaluate the changes which we might like to see in the syllabus as a result of NATURAL Version 1.2 and how our third-party education vendor will be able to address those changes;
- On the subject of the Introduction to NATURAL Course recently held at MIT and not sponsored by NE SAGGROUP, there seems to be substantial interest throughout the group in scheduling another such course under the aegis of NE SAGGROUP:
- The ADABAS Operations
 Course which we began to
 discuss in February has not
 been finalized. The content of
 the course has been proposed
 and rewritten and will be

mailed to you during the week of April 26. Your speedy response to Alice Schafer will be appreciated. Dick Jones of Software AG responded to the original course syllabus with an offer of basically a one-day ADABAS Internals course based on existing course foils. The price of Software AG's offering was met coolly. After the group finalizes our own syllabus, we expect to entertain bids from third-party firms;

- A number of attendees expressed an interest in an ADA-MINT for Programmers course, which would address the growing disinvolvement of the DBA in the ADAMINT macro generation process. The Education Committee will research and report on possibilities in this area.
- 6. DBA Tools Committee Report . . .
- Tim McGovern and Buck Shaw, both of MIT, reported on the current developments in the DBA Tools Exchange for the NE SAGGROUP:
- Acceding to Software AG's wishes to decentralize the DBA Tools distribution and collection process, the DBA Tools Exchange will obtain and catalogue the semi-annual releases of Tools from the DBA Tools SIG in Reston;
- Any member of the NE SAG-GROUP can request tools from the Exchange—either the SIG Tools or the regionally developed Tools;
- The Exchange will provide a Tools Catalogue to the membership on a bimonthly basis;
- All members were encouraged to submit whatever tools they have developed to assist the DBA process regardless of the form they are in.
- 7. Recovery/Restart Presentation. Marilou Sazon of the Boston Company gave an excellent presentation on her experiences in the area of Recovery/Restart. Among the more salient points:

- Any RR plan must be equipped to deal with crashes of the ADABAS nucleus, either warranted or not, and with crashes of user programs;
- For crashes of the nucleus or the supporting hardware/software, the Autorestart/Autobackout procedures, coupled with daily (nightly) ADAFIX dumping or some sort of Fast Dump/Restore procedure, usually provide adequate protection;
- For application systems, ET recovery at the transaction level coupled with daily (nightly) unloads of the affected files usually provide adequate protection. Recovery to an ADAFIX dump is yet another option but is trickier because of the problem of RABN availability;
- Marilou stressed the importance of incorporating the dual logging mechanism in any RR plan. Specifically, she advises the placement of the logs on volumes not occupied by the WORK dataset and the use of USER EXIT 2 for backing up the logs automatically;
- The Backout/Regenerate procedure currently being used at The Boston Company was detailed;
- Lastly, Marilou suggested some further alternatives to the RR problem including using the checkpoint file to store off 'user checkpoint' data, using the AUDIT utility to create a logical backout procedure, and using partial mounts to create temporary data bases for off-loading and reloading the damaged file(s).
- 8. Discussion of NATURAL Version 1.2. Bob Myers of The Boston Company presented some of the early news on the functionality of the NATURAL Version 1.2 based on his review of the Beta NATURAL 1.2 Reference Manual, albeit incomplete. The Boston Company is a beta test site for NATURAL V1.2. For example,
- Substantially more powerful error handling;
- External storage of NATURAL maps for multiple-use maps;
- Full PF/PA Key support;

- An exit for the installation of NATURAL security;
- A STACK verb for a NATURAL 'macro' capability;
- RETAIN SET command for more efficient loop processing logic;
- NOERASE option on map definition:
- Map painting capability . . .
 still undocumented;
- More powerful edit masking.
 Bob Myers also presented a summary of Jim Bagby's (of Software AG) remarks on ADARUN parameter tuning which Jim presented to the SAGGROUP 7 meeting in February.

The MITRE Corporation graciously hosted our ninth general membership meeting on June 17, 1982. 34 persons from 11 member organizations attended.

General Business

- Nominations were accepted for the position of Regional Representative. Tim McGovern was the only nominee and was elected RR for the next year. His term ends with the close of the Conference in June 1983.
- The next meeting of our organization will be hosted by Mel Bemis at Northeast Utilities in Hartford, Connecticut on September 16, 1982. Despite the long layoff between meetings, the group is expected to continue to keep the lines of communication well-oiled during the summer hiatus.
- · The question of whether consultants and other Software AG affiliates should be allowed to attend our meeting was raised. Tim McGovern suggested that the consultant exclusion policy which was decided at the February 1982 meeting should be modified to allow consultants who are actively engaged (or otherwise affiliated) with member organizations to be welcomed. The change to existing policy was accepted. A suggestion to designate one or more meetings as "consultantattended" meetings was not adopted. No other changes were suggested.

Committee Reports

 Alice Schafer discussed the status of the ADABAS Operations Course Survey. She has closed the survey period. She will collate the results, prioritize the topics, develop a syllabus and begin to entertain bids for the course. We hope that such a course could take place sometime in the fall.

· Buck Shaw discussed the status of the DBA Tools Committee's efforts. The Committee is waiting for Release 3 of the Tools Tape from Reston. Jim Crawford has assured Buck that the tape will be in hand within 30 days. Immediately upon receipt, Buck will advise the membership of the contents and availability. The collection of Tools from the NE SAGGROUP is still in its infant stages.

· Buck Shaw distributed the first version of the NE SAG-GROUP Member Profile. Comments and criticisms are expected and encouraged. An official version of the Profile will incorporate member suggestions and be published for the September meeting.

· The changes in the NATURAL environment due to NATURAL V1.2, it was generally believed, would seriously obsolete Roy Wood's existing Advanced NAT-URAL syllabus. The availability of NATURAL V1.2 third party education is still unsettled.

Rodger Mattlage of the Boston Company has the most experience in the group now because of his beta testing responsibilities, and the group might seek an arrangement with the Boston Company where Rodger would hold a course on the NATURAL V1.2 and how it changes (or should change) the on-line applications development process.

The MITRE Security System Alice Schafer made a presentation of the MITRE approach to ADABAS file and field security.

 MITRE's Security system was created in response to typical security demands:

-to protect data from unauthorized access and/or update; -to restrict access and update to certain authorized programs or utilities.

 MITRE found that vanilla ADABAS Security contains certain limitations, including: -the overhead involved in frequently changing large numbers of passwords is severe: -the various ways in which a user must supply the password (via NATURAL, user-program or utilities) is inadequate and can easily be compromised.

 The MITRE Security system then has the following characteristics:

1. MVS passwords are used on ADABAS ASSO and DATA. 2. ADABAS passwords are used on all ADABAS logical files.

3. Access or update privileges are granted on a program name and authorization code basis

4. These authorization codes must be safeguarded similarly to ADABAS passwords and normally would not change. 5. A password-protected en-

crypted ADABAS file contains the program to authorization code to ADABAS password relationships.

6. A source-protected Password Lookup Subroutine is used to "authorize" a user and to temporarily insert the ADABAS password in the submitted JCL stream. The temporary JCL is deleted after use.

7. The Password Lookup Subroutine is also used to perform the Security Administrator function via calls from the NATU-RAL-based Authorization Update Subsystem.

 In summary, the advantages of the MITRE Security System are that password modification is performed with relative ease and that passwords are suppressed from printed or viewable output. Together, this provides an adequate level of data protection.

 A potential disadvantage of the MITRE system is the need for several hours per week of part-time administrative support for the system.

Projections of the Software AG Product Environment. Bob Myers of The Boston Company presented some of his views of what a typical ADABAS environment might look like in the September 1982 to September 1983 timeframe. Participating by proxy was David Little (also of The Boston Company). Given the current development information and the levels of testing efforts of various SAG products. Bob believes a possible environment as consisting of:

 ADABAS, with VTAM or CTCS for inter-machine communication. The support of the multimachine environment is now a reality. In the future, the possibility of such an environment might be required by corporate policy, performance needs or security and disaster planning or others.

 NATURAL V1.2 with NATURAL Security feature. The NATURAL V1.2 product changes the nature of the NATURAL product radically, and the Security addon permits the DBA, or other Security Administrator, to manage the adhoc programming environment without disturbing the production system environments in NATURAL.

 COMPASS and ACCESS facilitating TP and system development. The COMPASS (COM-PLETE Parallel Access and Security System) is perhaps the most exciting new feature of the product line. It relieves the need for an SPF-like front end to COM-PLETE. Further, it allows and facilitates the multiplexing of tasks. Thus, one can be running more than one NATURAL session, along with UQUE, UEDIT and other COM-PLETE tasks all at the same time, via a roll-dataset technique. Bob was not certain what the implications of this capability have for resource contention and for non-activity time-out parameter settings.

The ACCESS product allows any COMPASS user to talk to any other COMPASS user and to navigate through multiple physical machines. This moves us one step closer to the goal of transparent machine boundaries. This has implications for the data dictionary developments (see below). ACCESS also permits one or more users to be designated as "control status" users, which then authorizes that user to submit operator commands without being physically at the machine operator console.

• Data Dictionary, with enhanced Online DD aids.
The Online DD is being upgraded to allow more updating with fewer screen boundaries.
The DBID will now also be stored in the DDMs in the system file, which permits ACCESS and COMPASS to function correctly amongst multiple databases and multiple machines. With this DBID change, inter-DB joins are now a reasonable desire.

NATURAL V1.2 Beta Testing Results

Rodger Mattlage made an excellent presentation of his NAT-URAL V1.2 beta testing experiences. Rodger focused on how NATURAL V1.2 changes the nature of systems development and discussed this process in light of the new NATURAL features.

- PF Key support at three levels: Command level, Editor level, and Program level. A program must be specifically sensitized to a PF-key. Even still, one can expect source code simplifications as a result.
- Global Variables, indicated by a '+' prefix, can be defined and stored in the NATURAL region. It is perhaps important to note that when cataloging NATURAL programs with external global-variable references that the globals must pre-exist in the globals area.

 Error trapping within NATU-RAL programs can now be performed for most ADABAS commands. It does not check on the FETCH statement that the fetched module exists. New system variables *ERROR and *ERR-LN facilitate this error trapping.

 NATURAL V1.2 now permits the stacking of commands.
 Among other things, this would allow the development of more friendly user interfaces to NAT-URAL. Unfortunately, stacking %H is not supported.

 Full Online HELP facilities for all NATURAL commands and statements maximize a NATU-RAL programmer's interactive session productivity.

 An online internal sort for "test size" data will permit better online development of production batch jobs with obviously better turnaround time.

 External map definition and compilation permit the use of standardized maps now where previously multiple maps might have taken a different approach to the user interface.

 The passwords needed for access and update of ADABAS files can now be supplied through a variable reference or a global variable reference.

Pacific Southwest Region

Leo Webb Star-Kist Foods, Inc.

The meeting was hosted by Star-Kist Foods, Inc., on May 28, 1982.

A preference for a meeting format was discussed. We will mail out a questionnaire on program format and request suggestions on what subjects and presentations should be considered for program topics through next year.

Software AG has tentatively offered to host the June 25, 1982 meeting and present NAT-URAL 1.2 along with a demonstration.

With the prospect of more User Group sponsored education, there was a motion and a second to set up and elect a Treasurer. The charter will be to set up a bank account and maintain moneys for education through receiving and dispersing of funds.

An open discussion was held on the Las Vegas Conference. The main topic was the product announcements and how they over-shadowed the concurrent tutorials and workshops scheduled.

David Berg of Hughes Aircraft presented the minutes of the Executive Committee meeting at the Las Vegas Conference.

Myron Pullen of Ticor Mortgage Insurance is coordinating efforts for a NATURAL Advanced Techniques class. It was decided to hold two classes. Software AG will pursue a NATURAL 1.2 Introduction Workshop around mid July and the NATURAL 1.2 Advanced Technique class will be held in the fall.

Jean Roberts-Mertan of Star-Kist Foods, Inc., presented the Yourdon "Information Modeling" class being offered July 19–23, 1982, in Long Beach. This is a special offering to the SAGGROUP by Yourdon. Yourdon has indicated willingness to offer this to other regions. This class may be postponed to a later date.

The meeting was adjourned at 1 p.m.

Southeast Region

Larry Goodman American Family Life Assurance

The Southeastern Users met on March 17, 1982 at Peachtree Plaza Hotel in Atlanta, Georgia. Twenty-seven representatives from 14 organizations participated.

Larry Goodman opened the session with a summary of the days Agenda. Introductions of Software AG participants and Southeastern users followed.

Kevin Wilson from Duke Power presented a summary of his ADABAS SM04 testing.

Al Wolfson with Software AG gave a slide presentation on NATURAL Graphics. The Graphics interface requires graphics driven software such as IBM's GDDM as a prerequisite.

Bill McCrosky gave a presentation on Software AG's consulting services and education group. Some of the services offered are listed below:

- · Contract programming;
- Conversion assistance;
- · Performance and tuning assistance;
- Project management/system analysis.

A general discussion followed. Topics discussed were the upcoming Conference, nominations for 1982 Regional Representative, and proposed group projects.

Reginald Ellis of American Family Life presented the role of Data Administration and its structure within the organization. Emphasis was placed on data awareness within organizations and the evolving role of Data Administration.

Judy Pesses from Software AG gave a presentation on performance and tuning of ADABAS. Judy explained that each environment had uniqueness which must be considered when tuning. Some tuning considerations are mentioned below. SAG will be releasing tips on performance and tuning at a later date.

- Teleprocessing—run ADABAS above the TP driver in a TP EXCLUSIVE ENVIRONMENT. NOTE: Do not run batch jobs along with on-line in this configuration:
- ADABAS placement critical for good performance separate associator dates and work on separate packs and channels where possible. Placement in association to system page and spool data sets should also be considered:
- Avoid complex commands wherever possible;
- · ADARUN parameters should

be tuned cautiously measuring the affect as parameters are changed.

- LBP-needs to be very large increase; check region size when increasing this param-
- LFP—default 4000, min 1,000. increase if RC 42:
- LI—increase if RC 71;
- LP-should zap as default; never change after unsuccessful ADABAS session;
- LQ—should start with default; then increase;
- LS—depends on installation: sometimes used to constrain find sorted:
- LWP-default should be at least (2 K LS). Regions size increase if this parameter changes.

Other ADARUN parameters vary on installations usage.

Southwest Region

Bob Glasscock Dow Chemical

In the absence of Bob Glasscock, Bob Holub of Superior Oil opened the meeting with roundtable introductions and discussions. Bob Becker of Foremost Insurance gave an excellent talk on performance and tuning of ADABAS 4.1. During his talk he addressed the Foremost Insurance method of placing the data and associator of all the files across packs to gain performance considerations. He also discussed ways of reducing OPEN and CLOSE calls to reduce the number of buffer flushes and the adjustment of the Buffer Flush parameter.

Bryan Smith of Software AG gave a presentation showing the direct calls which various NATURAL commands generate and discussed which commands to use to cut down on CPU time and the number of I/O's. The attachment to these minutes shows the examples and conclusions discussed.

Sierra Pacific Region

Colette Farabaugh Castle & Cooke, Inc.

The latest meeting of the Sierra Pacific Users' Group was held on June 29 at the County of Sacramento. There were 22 people present, representing 10 ADABAS sites.

Our first order of business was to elect Wayne Peterson of Teale Data Center as recording secretary. Then, after Bob Taylor of Software AG made announcements concerning the resignations of Keith Tipton and John Weil from the company, the remainder of the meeting centered on the Conference.

Alan Routhier, President of the International Users' Group, reported on several meetings the Executive Committee held during the Conference. Don Brown of the County of Sacramento talked on the ADABAS sessions he attended. Jim Reiner, also from Sacramento County, reported on the NATU-RAL presentations. Some of the new NATURAL products, such as NATURAL Graphics and NATURAL 1.2, were discussed. After lunch, since the County of Sacramento is a beta site, a demonstration of NATURAL 1.2 was given.

Our next meeting is scheduled for September 21, again in Sacramento. Software AG will be requested to provide a speaker on the new products and releases they are offering, most notably NATURAL 1.2, NATURAL AF, and the NATU-RAL Security package. The County of Sacramento will give a presentation of their law enforcement system which is currently in production using

ADABAS.

Communication With Technical Users Data Administration/ Data Base Administration SIG Report

Carole Schermer Chemical Abstracts

One of the concerns of a newly created Data Base Administration Unit is establishing good communication with data base users. This article will focus on communicating with technical users: systems analysts, designers, and programmers who must interface with the data base to implement their application systems. Communication has many facets: day-today interface on specific file and program design development, education in data base methodology and theory, problem resolution support, and announcement of new and changed products and ser-

This article will address some of the tools available in day-to-day communication needs. One highly desirable goal is to employ some amount of standard communication between the DBA staff and the project development staff. While each application may have varied data and access requirements, the type of information needed to define a data base application differs little between projects. The DBA needs to know the physical and logical formats of the data elements, their relationships within the data base, the size of the data base files, growth projections, recovery requirements, etc. This carries along to the programming level as well: the DBA must represent

the programmer's access, update, and reporting requirements to the DBMS. For ADABAS, this could be in the form of a NATURAL userview, ADAMINT macros, direct call parameters, or some other interfacing technique.

One method useful in capturing data base related information is the creation of standard forms and procedures. While forms, cannot capture all the nuances and detail present in data base relationships, they do provide a uniform communication medium of the essential requirements. Information on the form represents the product of lots of discussion and decision making in creating the data base application. Use of standard forms and procedures can provide the following ben-

- 1. Forms insure a level of uniformity in dealing with technical users. All essential information dealing with the data, its relationships, and access requirements can be captured.
- 2. Forms eliminate confusion and account for all information needed by the DBA. Without a form, the DBA may forget to ask a question; with a form, the question is asked all the time.
- 3. Paraprofessional, clerical, or less-experienced DP staff can be trained to create data base file definitions, userviews and other DBMS constructs from the information recorded on a form. These activities need not continue to involve senior DBA staff.

Forms and procedures do require some time to create and should be reviewed and changed if needed. The payoff is well worth the time and effort. Forms that Chemical Abstracts Service uses to record file definitions, userviews, AD-AMINT requirements, and report ADABAS and NATURAL problems can be found in the 10th International Users' Group Conference Proceedings (The Paraprofessional's Role in Performing Selected Data Base Related Functions at Chemical Abstracts Service by Daniel Keller). The Government Printing Office, Washington, D.C., has also developed forms to capture similar information (contact Robin Schwartz, 202-275-3389). If other users have developed or are in the process of thinking about creating forms, standards, and procedures to better control the relationship between the DBA and other development units, please let me know.

P.S. I would be interested in finding out about users' approaches to Data Administration and Data Base Administration within their organizations. One of the goals of this special interest group should be to form a centralized resource for users who are interested in learning more about DA and DBA functions and those who have that information and experience base to draw upon.

Large Data Base SIG Report

I would like to thank Sue Birgeles who shared with us some of her experiences at Donnelley Marketing. Many items of interest to the Large Data Base User were discussed. Specifically, we were glad to see that Software AG is aiding the Large Data Base User with new software enhancements like the "Reflective Data Base" feature with the

promise of better restartability in those long running utilities and a Repair Block facility.

There were several sessions on ADABAS performance and a lot of valuable information was shared. Some areas of performance that many users have found to be important are:

- 1. ADARUN parameters (specifically the LBP parameter);
- 2. Disk Placement;
- File Placement;and let us not forget,
- Applications Design.

RSEQ—XEDIT Macro for NATURAL Renumber Function

This XEDIT Macro operates on NATURAL programs which are being edited with the VM/SP Editor, XEDIT. It presumes that either:

 CMPEXIT is being used to store and retrieve NATURAL program source and object code; or

NATURAL programs are developed in the XEDIT environment and loaded into a system file for final checkout.

In either case, this macro has proved to be a valuable tool.

SETTIME AND *TIMD Commands

Steve Robinson S. L. Robinson & Associates, Inc.

As evidenced by articles in the last several newsletters, the utility of the SETTIME and *TIMD commands is becoming more widely known and employed in the NATURAL user's community.

Below is a short program, using SETTIME and *TIMD, designed to demonstrate the "cost" of inappropriate use of the ADABAS ET command. (End of Transaction in Natural).

Many shops badly abuse this powerful command and its associated facilities (e.g. BT). The ET command should serve one of two functions:

 Delineate a set of logically related updates, e.g.
 Add an order record to the order file;

Update two fields in a customer record to reflect one more order for this customer and an increase in total dollar value of orders:

Update a variable number of product records (one for each line item of the order) to reduce quantity unallocated fields.

2) Establish a recovery time unit. This is especially appropriate in a batch run which will update a large percent of the records in a file, e.g. passing a 200,000 record file making a minor update to each record. Issuing an ET command every N transactions will permit recovery in considerably less time than would be required to rerun the entire program. Typical values of N might be in the range 50-200 depending on the extent of the updating going on and the size of the entire update run.

Unfortunately, many shops use the ET command as a

mechanism to simply release records. The sequence of programming mistakes goes something like this:

READ FILE X IN PHYSICAL SEQUENCE ACCEPT IF ______UPDATE END OF TRANSACTION LOOP

The above usually produces a record hold queue overflow. Therefore the following code is erroneously employed:

READ FILE X IN PHYSICAL
SEQUENCE
IF ______THEN
DO
UPDATE
DOEND
END OF TRANSACTION
LOOP

This avoids the overflow problem but creates horrendously long execution times. Note: the ET command is simply being used to release records. (updated and non-updated) The correct program logic was demonstrated in the last newsletter, i.e., do not hold a record unless you intend to update it.

To comprehend the cost of inappropriate ET commands, try the following program on your system:

SETTIME
FIND 2 WITH MAKE = 'GENERAL
MOTORS'
END OF TRANSACTION
LOOP
WRITE 'ET LOOP TIME IS' *TIMD
(0010)
SETTIME
FIND 2 WITH MAKE = 'GENERAL
MOTORS'
LOOP
WRITE 'NON ET LOOP TIME IS'
*TIMD (0060)
END

We have seen ratios of NON ET/ ET times of 1.5 to 6 for the above example. Note: If you write a similar example which selects more than the 284 records selected in the above example, you will have to "edit" *TIMD ala the examples in the last newsletter.

Natural Features SIG Report

The past Conference was very exciting and informative for all users who were able to attend. I would like to thank all those who participated in the NATURAL workshops and those who presented papers. User participation and sharing of information is what the Conference is all about.

The following is a summary of the NATURAL topics covered although it will primarily deal with the NATURAL Features workshop and the Change/Enhancements workshop.

The NATURAL Features workshop covered three areas of interest—(1) the state of NATURAL one year ago and the Change/Enhancement requests at that time; (2) the current Change/Enhancements; and (3) further requests and questions by the Users' Group. First, NATURAL a year ago.

In the area of Change/Enhancements, a breakdown of the top vote receiver of 1981 looked like the following:

It is interesting to see where the users wanted the general development emphasis for NATURAL one year ago. Some of the requests dealt really with cosmetic changes to what already exists; however, the large vote receivers were primarily in the area of language changes. These are also the ones that will take the longest to implement as we will see when we look at the top vote receivers for 1982. It may also interest you to see a breakdown of the responses to all change requests submitted last year. So here is a look at another set of stats:

So, the first two tables summarize where we have been. Now a look at where we are going.

Software AG is proud that over one-third of the change requests could be answered 'in V1.2'. Here we see that the requests with the most votes still deal with language changes and will be implemented in the future (1-2 years). The response to the library management request deserves an explanation. More and more of the enhancements to NATURAL will require that the source and object code be under the control of NATURAL. Therefore, in order to be a recipient of the latest and greatest features, you will need to leave the source and object right where NATURAL puts it.

The Features workshop concluded with an excellent discussion of features for which many users see a need. The topics discussed were ample evidence that there are some very sharp and astute people who use NATURAL. David Alexander of Bud Antle Inc., John Kay of Foremost Insurance Company, and Karl Gingrich of Marathon Oil are just a few of the users who were involved in

workshops and offered new ideas. As the Features workshop closed, some of the topics covered which deserve attention by SAG included the following:

- · Dynamically load DDMS;
- Date/time stamp for source and object;
- Perhaps an autosave for NAT-URAL much like CMS;
- Put SAGTIPS in printed form;Dynamic storage acquisition
- online;
- Debug tools and features.

There were many other workshops and user presentations as well as 'adhoc' get togethers among the users. There were 12 NATURAL V1.2 beta test sites represented at the conference and we held a meeting to discuss its development, bugs, and release date. Not that dates are really that important any more, but word (rumor?) had it that NATURAL V1.2 would be generally available in August. The VI.2 documentation was also available for inspection. I must say that everyone will be very satisfied with the new format, completeness and correctness of the documentation.

The workshop chaired by Dave Parfrey dealing with teaching NATURAL to the user attracted some of the most vocal people and proved to be the most controversial topic of the workshops. There are just so many different users, environments, and needs that there is a full range of answers to "how do you teach NATURAL to your users?" Various sites use video tapes and notes for training the users. Some sites try to break the users into two or more groups and train them accordingly. There was controversy over whether users ever need to know about ADABAS. The answer seems to depend on the people using NATURAL, what they will use it for and what their data includes. So, the whole idea of answering the question "how do you teach NATURAL to your users?" with a very detailed answer and step-by-step procedure is not possible. Anything beyond an answer of "very carefully" is very dependent on the particular site.

Managing the NATURAL environment was the topic of another workshop. This workshop exploded with ideas when it got the subject of controlling the user from being inefficient. I found that there are a few users who have gone to great pains to control everything the user does by modifying many of the software products that they use. Here the "how to" of controlling the user was really dependent on how much the user was to be controlled. A very unique idea was really dependent on how much the user was to be controlled. A very unique idea in the area of controlling a NATURAL user from abusing the system was presented by John Kay. He suggested that DP cannot control the user from being inefficient if he is allowed to program. This is because the control must be at ADABAS, not in NATURAL. This perspective was different

than most of the discussion but may be the area where control really is possible. Discussion also included: setting up a test and production system file, CICS as a core hog, and the use of prototypers by Chairman Karl Gingrich.

John McAra of SAG wowwed us with NATURAL graphics. NATURAL Graphics will be available in V1.2 and will be the bridge between the DBMS and the graphics package, such as IBM's GDDM. Here is an outline of the presentation: Why graphics?

Peter Pagé was involved in presentations involving NATU-RAL V1.2 features, NATURAL V1.2 Security, and NATURAL Advanced Functions. V1.2 contains many performance improvements. Here are a few:

ADABAS commands—L1 will

- replace sequence of S1,S1,L1;
 Open/close processing is eliminated with OPRB = NOOPEN;
- Object code is blocked to 2K;
- Source code is blocked to 60 lines per record;
- A much-used object module can be converted to a load module and linked with NATU-RAL at gen time.

I will let SAG tell you all about the individual features of V1.2. They know a lot more about it than I do.

A general purpose inquiry facility was demonstrated by Len Jenkinson of the SAG British Development. This facility will be for the end user who has a knowledge of his data but has no DP skill. This may be available in a few months. The inquiry request will be stored as a series of parameters, not as a program. This sounds a lot like the "NATU-RAL-an adhoc query lanquage" that we bought a few years ago. The demonstration looked very promising and I look forward to using this facili-

There were a few people at the last conference who had ideas for Special Interest Groups. Talk to the NATURAL Product Rep about your ideas and then the SIG will be recognized. There are so many of you out there who have discovered techniques for dealing with unique programming situations. The workshop for NATURAL techniques proved that there is an interest in sharing tips and techniques that users have developed. One very useful vehicle for sharing this information is the Newsletter—this very magazine you are reading. I encourage everyone to consider writing a short article for the Newsletter explaining your techniques, ideas, or questions if you have

ADABAS-M Product Rep's Report

VAX DBMS Users Gain Native Mode C Language Support with ADABAS-M SAGNA

Software AG of North America announced support for the native mode C language for ADABAS-M DBMS users on Digital Equipment Corporation VAX-11/730, 11/750 and 11/780 computers running under the VMS operating system.

Users may interact with the system in four ways: by CALLs from online or batch programs; from terminals using the ADASCRIPT-M query facility; via terminals or batched commands with the Report Writer; or through the interactive data base administrator utilities. User-written application programs may be in any of the 32bit VAX-11 languages including BASIC, BLISS, C, VAX-11 COBOL, CORAL, VAX-11 FOR-TRAN, Macro-32, Pascal, and PL/1.
